Mayor: 'Somewhat' good news for 2020 City faces 2.6% agglo hike but decries process used

By LAUREEN SWEENEY

Westmount's share of Montreal agglomeration services for 2020 based on property valuation is expected to rise 2.6 percent for 2020, Mayor Christina Smith announced last week. The cost to the city – and taxpayers – of \$59.9 million compares to \$58.4 million in 2019.

In announcing the city's share, or *quotepart* as it is called, after the draft budget was tabled, she said she was anticipating Westmount would still be able to bring in its total operating budget December 16 at the rate of inflation, as planned. This includes local expenses and agglomeration services.

"It's somewhat good news," she said of the local agglo increase. "I'm glad it's not higher but we continue to be against the process used to determine the *quote-part* and what we receive (in return) in shared services."

The city's 2.6-percent increase despite the rise in the new property valuation role for 2020-2022 compares with 2019's increase of 3.6 percent and the 2018 hike of 6.7 per- *continued on p.* 11



Paper bags used once can be worse: Cllr. Brzeski Will Westmount ban single-use plastic bags?

What plans does Westmount have for meeting targets set for the Montreal agglomeration to divert 70 percent of its garbage from landfill by 2025 and 85 percent by 2030? And will the city ban the use of plastic bags?

These were questions asked by two residents at the council meeting November 4 after the targets were reported by Councillor Marina Brzeski. While the targets were "ambitious," she said she was encouraged that Westmount had diverted 54.4 percent of all garbage in 2018 compared to 53.5 percent the year before (see story November 5, p. 1).

To meet the targets, explained Brzeski, commissioner of sustainability and accessibility, Westmount would have to "ramp up" ways to reduce garbage at source, encourage greater use of the city's composting and recycling programs, engage residents and encourage retailers to shift packaging habits.

An action program regarding this would be worked into the city's 2020 operating budget that would include extending recycling and composting programs in parks to "separate at source."

But would Westmount follow IGA's ban to eliminate plastic bags?

Engaging retailers

Mayor Christina Smith said "we know we have to move away from the use of plastic bags," but that Westmount wanted to work with retailers to get them onside rather than levying heavy fines and other ways various municipalities were using.

Citing a recent study by Recyc-Québec evaluating the life cycling of packaging, Brzeski said, "If you were to use a paper bag once and throw it away, it would be more costly to the environment than a plastic one," all things considered. The report's conclusion was that if using bags, re-use them.

When told the city was developing an action plan for 2020, Victoria Ave. resident Russ Brown, a climatologist who worked many years for Environment Canada and is a member of the Healthy City Project, said the city could count on the organization for help.



Meeting takes place for Districts 1 and 2 Traffic and safety main concerns voiced by residents

A combined meeting for residents of Districts 1 and 2 took place on November 20 with Mayor Christina Smith and their respective councillors working to provide those attending with an opportunity to raise concerns that turned out to be mainly traffic related, according to the mayor.

Roughly speaking, District 1 is the area north of The Boulevard and Cedar (including the south sides of those streets); and District 2 is north of Côte St. Antoine, and west of Church Hill and Aberdeen.

20 attended

The 20 residents attending were equally divided between the two districts, said District 1 councillor Anitra Bostock, who hosted the meeting along with District 2 councillor Philip Cutler and Mayor Smith. They were accompanied by city director general Benoit Hurtubise, Public Security director Greg McBain and five Station 12 police officers including Lieutenant Jonathan Chase.

"What was nice was that people came to the table with an open mind," said Bostock. "Three residents of Lansdowne just south of The Boulevard told us they were concerned about safety from traffic speeding in their block, so it was handy to have police there who would follow up," Bostock explained.

Monitoring sidewalk safety

Pedestrian safety was also raised about contractors parking partially on the sidewalk as well as cars in driveways sticking out over the sidewalk. McBain told the *Independent* last week that so far this year, the department had issued 172 tickets for parking that obstructed pedestrian passage or contractors parking with two wheels on the sidewalk.


Other attendees asked for north-south connector bike lanes between The Boulevard and Westmount Ave., and for more electric charging stations.

Garbage missed

A resident of Sunnyside also said his garbage was missed regularly by the city contractor despite his calls to the city. As a result, the city has since fined the company, Bostock said, so hopefully his address won't be missed again. "This was the first time we have undertaken this initiative," she said of the event, "so I didn't know what to expect. But it was something that we would certainly like to do again. We came out of the evening with a list of follow-ups and are appreciative that residents took the time to come out and meet us."

Notice cards inviting residents to the meeting at Westmount Park Church had been mailed out to some 4,000 addresses in the two districts, she said.



Police Report Police beat quiet, except for car thefts and stolen identity

Officers at the Montreal police's Station 12 on Stanton St. had a relatively quiet week, with the exception of two stolen cars and a case of identity theft.

Sometime between November 24 at 9 pm and November 25 at 7 am, a sports utility vehicle was stolen from the driveway of a home on Ramezay Rd. near St. Sulpice Rd.

"When the owner went to his vehicle in the morning, the vehicle was gone," said community relations officer Adalbert Pimentel, adding that there was no evidence of a forced entry.

Although a security camera, which might have provided images of the perpetrator, was found nearby by the investigators, it was not operational at the time of the offence, Pimentel added.

SUV stolen on Renfrew

A General Motors-branded SUV belonging to a resident of Westmount's Renfrew Ave. was stolen around 7:30 pm on Nov. 25. After the owner reported the theft, neither he nor the investigators were able to locate it with GM's on-board OnStar vehicle-tracking system as someone appeared to have deactivated it, Pimentel said.

As with the previous stolen car case, there was no evidence of forced entry, such as broken window glass in the driveway where the vehicle had been parked, he continued.

Identity theft, police advice

A Westmount resident filed a complaint at Station 12, alleging that an identity theft had been perpetrated against her.

In the police report of the incident, she said she had recently received a call from a debt collection agent claiming she owed money from an unpaid bill issued under her name by a cable company.

After contacting the cable company, the woman was able to determine that an unknown suspect had used her identity to open the account for which an outstanding amount was now due.

With identity theft becoming an increasingly common crime, Pimentel said one of the best responses by victims is to open a surveillance account at credit

The identity theft problem has taken on such magnitude that the Montreal Police Department has been providing special training in cybercrime to some of its staff - including Cst. Pimentel who took part in one such seminar.

Among the issues Pimentel said were discussed during the training session on Nov. 26 were the abuse of IRC Chat and social networks by hackers, online fraud artists and vendors of child pornography.

"The darknet is where you find a lot of suspicious activity," he said, referring to a type of activity on the world wide web where encryption allows crime, including gun-running and drug-dealing, to take place undetected.

A new frontier of illicit cyberactivity, he added, is the Internet of Things (IoT). This involves a growing number of Internetconnected appliances and devices, including household thermostats, security monitors and "smart speakers" like Siri and Alexa, which are coming under cyberattack as they contain personal information which can be used for identity theft.

"It's good to be conscious that the tradeoff for using these things is privacy," said Pimentel, noting that, for example, smart speakers are programmed to listen and can pick up personal information that comes up during conversations that are private.

Suspect followed, fined \$1,938 for graffiti

A 28-year-old Montreal man was issued three tickets at \$646 each for graffiti painted at three locations November 10, Public Security officials said. Arousing suspicions, he had been followed by public safety officers after he left Westmount Park at 9:34 pm, headed toward Westmount High School and wound his way south to the Greene/Prospect tunnel.

Described as slipping along in mud at the new highway wall, he was seen dropping a can of white spray paint. Boxed in by patrol cars, he surrendered, according Public Security director Greg McBain.

The same white tag in fresh white paint was found at three locations: in the tunnel

just south of Centre Greene, a communications box in a lane behind Columbia and a concrete block at 4200 Dorchester.

Police were called and it was decided to fine the man for graffiti under the municipal by-law rather than charge him criminally. He was reported to have apologized and had no record of "similar" offences. The file was submitted to the city's Legal Services department for possible collection of clean-up costs.

Crane gets ticket for \$1,291

A crane set up outside 377 Metcalfe Ave. November 22 was found in violation of its city permit to occupy public space, according to Public Security officials. One condition it had not met was the creation of a safe pedestrian passage; another, that the feet of the stabilizer legs not be placed on the sidewalk unless a deposit had been made against damage to the concrete. It was reported to be the second time this equipment's operator had violated conditions since June 14. It was described as being close to a school (Akiva) where a safety campaign has been under way. No warning signs were posted.



LET THE PATH MEANDER

I have to disagree with your editorial of November 19 (p. 6) about making Westmount Park traversable by pedestrians.

I am a walker and frequently walk through the park on my way to Greene (or farther) and back. It is the fact that the path meanders slightly that makes it pleasing. If I want straight lines, I can walk on any street. A park is not a throughway. The path opens to delights each season - the snow-covered gazebo, dogs cavorting in the dog run, people just enjoying a sunny day in the "Shakespeare in the Park" dell, the blossoms in spring and the ever-changing colours of the leaves in the autumn. A slight detour around the dog run and the gazebo only add to the walk's charm. I don't need to slow my pace, yet it is a relief from the rest of the walk through city streets, where cars and bicycles make walking more challenging.

Sometimes we need a break from efficiency!

Where I do agree with you is that the path needs to be safe. The section that collects water – and, in winter, ice – needs to be levelled. Snow clearance needs to be done, though I was surprised this year to see how quickly and well the path had been cleared after our first snowfall. We don't need another highway through the park. There are enough straight paths elsewhere!

SUSAN BLOOM, LANSDOWNE AVE. *Editor's reply:* I am all for meandering paths too, but I think we can make one exception for such an important case, and I am skeptical that a meandering path will be well cleared of snow in the long term, even if the quality improves for a season or two. Good design makes things easy for users, and for maintenance and maintenance staff, and increases usage, which – in the case of walking – is a goal of many people in Westmount. Everyone pays for poor design, over and over again until the project in question is demolished. – DP.

STRAIGHTEN THE PATH, MOVE THE DOGS COMPLETELY

I am fully in agreement with the need to straighten the east-west footpath through Westmount Park at de Maisonneuve (as expressed in your editorial of November 19, p. 6). But moving the dog run "north towards Sherbrooke a bit"? So, in addition to dogs en route to the run occasionally harassing (or at minimum sniffing at) third parties, and the peace of the lagoon being disturbed by yapping in the run, are you suggesting we might have the dogs splashing about in the water?! (There is simply no land leeway available.) Much better to move the dog run back to its original location, at the corner of St. Catherine and Lansdowne, which is presently a rarely used part of the park. and would minimize disturbance since it is across many paths from it.

Bankruptcies and harsh winter City writes off \$61K in unpaid hydro bills for 2016

City council November 4 wrote off a total of \$61,419 in unpaid Hydro Westmount bills for 2016, most relating to clients described as "moved out," according to accompanying documents.

The bad debts compared with a total of \$10,676 written off last year for 2015 as is the city's custom of writing off uncollected debts that are three years behind. While the smaller amount written off last year had been described at the time as "much improved" over the previous year, this year's list went without comment.

City director general Benoit Hurtubise later told the *Independent* that this year's higher total was related to "a few bankruptcies on Greene Ave." and a harsh winter in 2016 that had led to higher bills.

As well, "it was Year 1 of our new billing system ... and the bad debt process was not optimized." While the bad debts fluctuate over the years, he explained, "our average has been around \$45,000."

The amount written off was listed by a collection agency as ranging from \$5.79 (attributed to an apartment dweller on Clarke) to \$5,738 for a food outlet that was very much in business last week under a modified name on a nearby street.

Of some 139 account numbers listed by the agency, some 107 had residential addresses - many at apartment buildings while the others appeared to be commercial accounts.

Westmount Historical lecture focused on artist Marian Dale Scott

Canadian artist Marian Dale Scott, who lived for years with her husband, the poet and constitutional lawyer F.R. Scott, on Clarke Ave., posted bail for students arrested during the "computer" riots at Sir George Williams University in 1969, an art historian revealed to the Westmount Historical Association.

While Marian Dale Scott appears quite conservative in most photographs taken of her during her 60-year career, "looks are deceiving," Gwendolyn Owens, director of

the Visual Arts Collection at McGill University, told the WHA at the Westmount Public Library on Nov. 21.

'Left-leaning'

She was "very involved in left-leaning groups that were against the Vietnam War in the sixties," Owens said, noting that Scott's husband was also ideologically leftleaning.

F. R. Scott was a co-founder of the Cooperative Commonwealth Federation (CCF), the forerunner of the New Democratic Party (NDP). The Scotts' circle of close friends included Dr. Norman Bethune, who is revered today as a communist hero in the People's Republic of China.

In an interview with the *Independent*, Owens, a Westmounter, said she hasn't yet found a written source linking Marian Dale Scott to the events at Sir George Williams, although she's working on it.

"It is something that I would obviously like to verify," she said. "But it would be consistent with who she was."

In her presentation on Scott, subtitled "A Studio of Her Own," Owens argued that Marian Dale Scott struggled to establish her identity while married to a man whose sterling reputation in Canadian legal and literary circles cast a shadow over her.

While acknowledging that the title of her lecture paid homage to Virginia Woolf's extended essay *A Room of One's Own*, which explored feminist ideals, Owens said she wasn't able to establish for certain whether Scott ever read Woolf.

What is clear, though, according to Owens, as well as others who spoke up during the evening, was that throughout her career, Marian Dale Scott kept a studio that was off limits to anyone who wasn't invited.

No one – not even her husband – was allowed in without her permission.

"You only got in there by invitation," Owens said. "I think it was a way – and this is where Virginia Woolf comes in – of demonstrating to the world *I'm serious about what I do.*"

Throughout her long career, Marian Dale Scott was "on a lifelong adventure – she never stopped exploring," Owens continued.

Her style ranged from precisely rendered industrial landscapes around the beginning, to abstracts with thick swirls of paint applied by hand towards the close of her life in 1993.

"Someone who's seen a painting by Marian Scott from one decade may not even guess that a work from another period in her career is by the same artist," said Owens. The city of Westmount owns two of Marian Dale Scott's paintings from the 1960s.

cent.

While the total overall share for the 15 demerged municipalities is reported to be up in the area of some 2.1 percent, some of the *quotes-parts* are above, others below.

These municipalities pay Montreal for what they claim is really more than their share of an array of island-wide services and over which they have no say. These include police, fire, transit, water supply and purification as well as a portion allocated to them for specific projects and costs related to the downtown area designated *"centre ville."*

Not expected to change

While Westmount's new *quote-part* was provided in the city of Montreal's draft budget tabled November 25, it is unlikely to change in the final budget to be adopted Friday, December 13, Mayor Smith said.

This will follow two weeks of on-going scrutiny by the Montreal/agglo Finance and Administration committee, of which she is a representative of the Association of Suburban Municipalities. This will involve much of her time until the budget is approved, she said.

It is part of the budget process once referred to by former mayor Peter Trent as "a charade" (see story October 4, 2016, p. 3).

While the current Montreal administration is being "more open," Smith said, in informing the demerged municipalities in advance of tabling the budget that had already been prepared by Montreal, there is little consultation with the suburbs. "It hasn't changed anything because it's the formula from Quebec based on property valuation that needs to be changed."

July transfers: Volume down, prices up

Note: The following article relates to the registration of deeds of sale for Westmount property in July 2019, gleaned from non-city sources. A list of sales can be found on p. 19.

Five house sales over \$2 million in July helped pull up the average price of Westmount real estate to \$1,918,627 from \$1,686,761 in June, though the number of sales dropped from 19 in June to 13 in July. The highest price was slightly over \$3 million for 425 Roslyn Ave., just north of Sherbrooke St., and the other four were much lower in the \$2-million range, below which prices went down to \$1,055,000 for a rowhouse in need of renovation at 24 Springfield Ave.

As it turns out, the latter sale represented the biggest mark-up of the month, since it was only evaluated at \$636,300, while the 425 Roslyn sale represented the lowest mark-up of the month, at 12.5 percent (note that the comparisons are still with the 2017 valuations, which remain in

Condos

The 13 sales in July had an average mark-up of 40.5 percent, the highest in the past three years (February was 40.4 percent) and moved the average mark-up for the year so far to 33.1 percent, up from 26.6 percent for all of 2018. Thus it is clear that the hot market continued into the summer and shows no signs of letting up. There were 85 sales in the first seven months of 2019, just about the same as in 2018 but well below the average volume of 108 sales year-to-date in the past decade. The average house price during that time is \$2,049,583, while in 2018 the average was \$1,934,309. Prices have almost doubled since 2006 on an annualized basis.

effect until the beginning of 2020).

Westmount's condominium market does not appear to have been quite as healthy, if the July figures are any indication. Only four condo sales were registered in July, with prices ranging from \$470,000 to \$890,000, two very low mark-ups including an apartment that the Bank of Montreal had seized a year ago and the other from an estate, but in fact the average mark-up of 23.7 percent is higher than for the previous three months, when 15 condos sold for an average 18.2 percent. So far this year, volume is way off in the condo market, a total of 26 compared to 43 in the first seven months of 2018, average price \$735,519 compared to \$1,079,087 last year.


