City now offering 3-instalment tax payment option

New council tables record \$146-million budget, aims to reduce headcount

The recently elected city council presented the city's operating budget January 13 at a record-setting \$145,712,400. Taxes are to be payable by residents in three installments rather than the traditional two.

The total budget includes the city's share of payments for agglomeration of Montreal ("aggo") services such as fire, police, transit and water as well as Westmount's much smaller contribution to the Montreal Metropolitan Community (MMC). These combine to total some 50 percent of overall city expenses.

In delivering the budget speech, Mayor Michael Stern announced that tax bills will now be payable in three installments (rather than two) to allow residents to

spread payments over a longer period "to ease cash flow for households while maintaining the city's financial stability." These dates are March 9, June 9 and September 9.

"The total tax revenue for 2026 is projected to increase by 5.9 percent compared to last year," he said. This is composed of a 3.3-percent adjustment to cover rising operating costs due to inflation and 2.6 percent for an infrastructure and capital work program.

This means that for 2026, the owner of the average single-family dwelling evaluated at \$2,705,159 can expect a tax bill of \$17,808 while the bill for the average condo of \$549,600 would be some \$3,620.

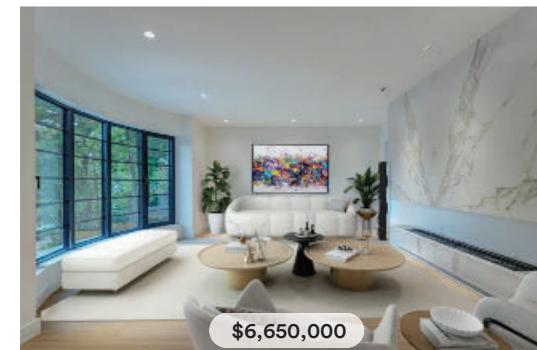

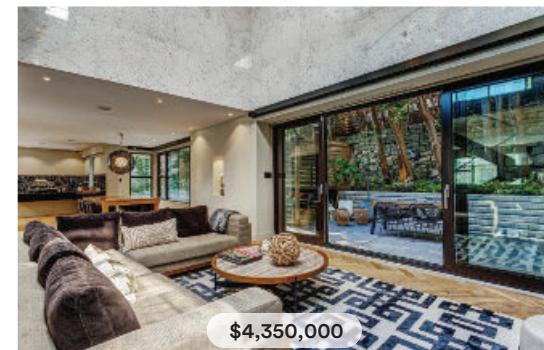

"As I get ready to leave, my heart is filled with gratitude for all the memories created while working for this amazing city," she told the *Independent*. the largest capital investment program the city has undertaken to date." It reflects the "scale of the infrastructure renewal required across the city."

Adopted were projects totalling \$48.5 million for 2026, \$47.5 million for 2027 and \$54.1 million for 2028.

The capital works program has long been regarded as a blueprint for funding "what and when" major projects are funded and carried out depending on priorities and changing needs.

Their funding requires a balanced approach, the mayor said. Over the three

years, the city anticipates adopting loan by-laws totalling some \$84.6 million along with some \$59 million funded directly from current operations ("pay-as-you-go") and the remainder from government grants (TECQ).

Work listed for 2026 by category totaling some \$48.1 million is listed as follows:

- \$31,820,300 for roads, water mains and sewers;
- \$5,828,500 for buildings;
- \$1,081,400 for the Project Office;
- \$2,850,000 for vehicles;
- \$1,266,900 for parks;
- \$4,270,000 for Hydro Westmount;
- \$936,000 for IT.

Why switch of council from Monday to Tuesday?

City council switched its meeting nights for 2026 to Tuesday from the traditional Monday, "for operational efficiency," city director general Julie Mandeville told the *Independent* last week.

Though the dates for this year were approved by council December 8 without comment, she explained that the change "allows staff to finalize files and gives elected officials an additional day to review materials before decisions are made." As

well, "it reduces scheduling pressure in weeks affected by statutory holidays on Fridays or Mondays."

The resolution was moved by Councilor Jeff Shamie stating that "Under the Cities and Towns Act, the council shall hold regular sittings at least once a month and council shall determine the schedule, setting the date and time of each sitting, before the beginning of the calendar year," as follows, each at 7 pm:

- January 13;
- February 3;

- March 17, changed from another date adopted earlier;
- April 14;
- May 5;
- June 2;
- July 7;
- August 4;
- September 9, a Wednesday owing to Labour Day;
- October 6;
- November 3;
- December 1.

Westmount, the total value of local properties has increased 5.6 percent. With the general residential property tax rate per \$100 of valuation, the tax rate for 2026 is listed on the city's website at \$0.6583, compared with the 2025 rate of \$0.6548. As a result, in general, tax bills will thus be increased by a higher tax rate and a higher evaluation.

Breaking down costs of services

"The central challenge in preparing this year's budget was to create the fiscal room required to address rising operating costs and necessary infrastructure investment while maintaining service levels and exercising restraint for taxpayers," Mayor Stern said.

Since this is the first budget of the current council mandate, it was decided that the mayor would present it rather than the council's finance commissioner, city director general Julie Mandeville told the *Independent*.

The city's 2026 budgeted costs for local operations are led by remuneration at close to \$35 million. Departmental expenses of more than \$21 million are topped by Public Works at \$12.6 million. Pay-as-you-go financing accounts for close to another \$15 million.

Citing some of the year's budget highlights, the mayor said "the city will operate with reduced overall headcount" with an aim to not automatically replace departing staff but to re-assess positions as they become vacant.

Costs in the Engineering department are being reduced "through a shift away from external consultants toward direct investment in infrastructure work. On the other hand, funding has been increased for the library and Community Events as well as Urban Planning" to complete the next phase of an overhaul of by-laws and an inventory of built heritage.

Mayor Stern described these as areas that matter "deeply to our community."

POTHOLE CITY (1)

I'm writing to share my concerns about the condition of several roads in the city. Many streets are in very poor shape, with large potholes and deep cracks that create real safety risks for drivers and pedestrians and cause ongoing vehicle damage.

I recognize that the city has already done what it could to repair numerous roads across Westmount, and I appreciate the efforts made by Public Works teams under challenging conditions.

I also fully understand that during the winter months repairing entire streets is complex and often not feasible.

At this stage, however, the situation has become unacceptable, and we cannot wait until spring to patch all the craters. Beyond the inconvenience, this situation has become a public safety issue that deserves continued attention. It is unfortunately a full-time job.

A structured monitoring process, supported by a coordinated team effort, would greatly improve outcomes. Providing Public Works teams with additional tools, resources and budget would support more durable repairs. It may also be beneficial to involve the Public Security team in this effort, as they regularly patrol the city and could help identify and report hazardous conditions in real time.

Temporary fixes alone are no longer sufficient for the scale of the problem we are experiencing. A proactive, well-coordinated maintenance strategy would greatly benefit the community.

Driving back home or in Westmount

was once a calming and positive experience; now it's like being in a war zone: very unpleasant and absurd.

I appreciate the city's attention to this matter and look forward to seeing continued action, improvement and communication to the residents in this file.

WHY CAN'T MAYOR APPROVE IMPORTANT \$3K EXPENSE?

The 16 households of the old train station complex [at the foot of Victoria Ave.] have long endured sewer infrastructure issues, with the ongoing risk of black-water flooding threatening both property and public health.

Over the past 25 years, these residents have contributed approximately \$2,000,000 toward municipal infrastructure, yet a

modest \$3,000 expense to clean and monitor the rear sewer pipe, well within Westmount's 2025 operational budget, remains unresolved.

Following the municipal election on November 3, 2025, Mayor Stern personally reviewed our email and approved the \$3,000 expense within 50 minutes on November 19, a responsiveness never before experienced and a rare example of decisive leadership.

Yet, at the December 8 council meeting, it was declared that the mayor's approval "is not applicable" and that the matter would not be escalated further. In less than three weeks, a timely and cost-effective measure to protect 16 households went from approval to dismissal.

It is unacceptable that such a reasonable, low-cost solution to safeguard 16 households and uphold long-standing civic responsibilities remains stalled. The city must honour the mayor's prompt and considered directive, proceed with the approved maintenance, and demonstrate the accountability and responsiveness owed to residents, particularly in light of the mayor's public statement indicating that his role does not include authority or oversight with respect to [this] matter.

Westmount Rotary built Manoir as its 50th anniversary project

Cllr. Aronson asks: Could a 'Tupper lots' seniors' residence be its 100th?

Councillors Shawn Moss and Matt Aronson joined the Rotary Club of Westmount on December 17 to examine the club's creation of the Manoir Westmount independent seniors' residence and to inspire members to consider the city's Tupper parking lots in the southeast sector as the site to undertake the creation of a second.

The reasoning went: It would be much easier to build than what the club achieved in 1979, when it carved into Victoria Hall and demolished two houses to build the current 125-unit residence.

Councillor Aronson motivated members of the Rotary Club of Westmount, which was founded in 1930, by saying, "I'm here today to suggest that your greatest work – your building work – might not be finished."

Some Rotary history

From Rotary archives, it is known that the club commissioned a study in 1974 to understand if Westmount could benefit from a seniors' residence. Controversy arose when the blueprints called for using Victoria Hall's basement level to house dining facilities and lounges, and for the demolition of two houses on Lansdowne Ave.

A total of \$5 million was raised privately (\$24.1 million in 2025 dollars) and two years later, on October 12, 1979, Lieutenant Governor Jean-Pierre Côté cut the ribbon. Within 12 months, every unit was occupied.

The 2021 census data indicates that 5,575 of Westmount's 19,658 residents were 65 or older, representing 28 percent of the population. Add those aged 55 to 64, and more than four in 10 Westmounters are approaching or already in retirement.

According to research that Councillor

Aronson provided on the cohort:

- median income for a Westmount resident over 65 is roughly \$71,000 per year,
- nearly 4,000 Westmount households rent – 46 percent of all households,
- nearly half of Westmount renters spend more than 30 percent of their income on housing – the threshold beyond which housing is considered unaffordable.

Councillor Aronson suggested to the club that another distinct asset, valuable both to the immediate locality and to the community at large, could be created were the Rotary Club to build a "Manoir Westmount #2" in the southeast sector where the city owns two parking lots.

The lots are between Tupper St. and

Dorchester Blvd. on both sides of Gladstone Ave. (see February 18, 2025, p. 16 for an aerial view).

Councillor Aronson asked Rotarians to reflect on what their 100th anniversary project could be.

Inspiration

"I came here to tell you that you've inspired me and hopefully to inspire you. I'm asking this club to form a feasibility committee. Not in five years. Now."

He went to propose a timetable that included breaking ground by 2027 and cutting a ribbon by 2029.

"It took you two years to go from referendum to ribbon-cutting for the Manoir. You showed us all it can be done. And perhaps... it can be done again."

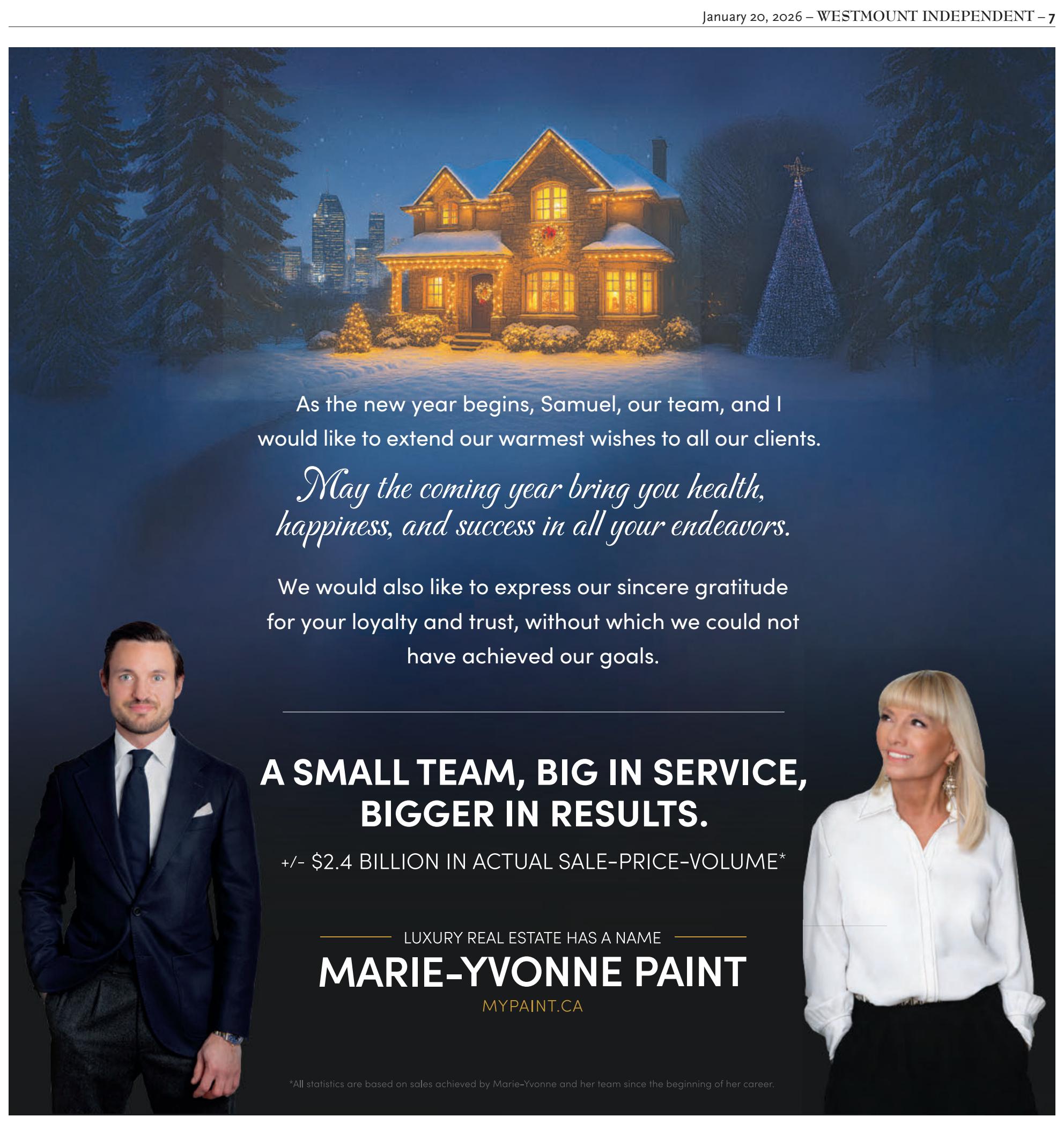

Westmount osteopath launches new book on 'Unwinding Bone'

Friends, clients and relatives of Victoria Ave. osteopath Scott Sternthal gathered at the Barakaris café/restaurant on Sherbrooke St. in NDG on December 11 for the launch of Sternthal's new book, *Unwinding Bone*, which is a guide to biodynamic skeletal therapy for professional osteopaths.

Osteopathy uses hands-on techniques like massage, stretching and joint manipulation to treat musculoskeletal issues. Its primary aim is to improve the body's natural healing by focusing on the connection between structure (bones, muscles, tissues) and overall function.

Canadian rules different

Currently, only the USA allows osteopathy to be practised as a branch of mainstream medicine. In that capacity, American MDs who are licensed osteopaths (DOs) can also prescribe drugs and perform surgery. Everywhere else, including Canada, osteopaths are restricted to manual techniques.

In a blurb by the publisher, Human Kinetics, *Unwinding Bone* is described as "a comprehensive, practical resource on biodynamic skeletal therapy (BST) – a gentle, non-manipulative approach that

engages with bone as dynamic, responsive tissue."

"Rather than focusing on the move-

ment of bones, BST emphasizes the movements within them, helping practitioners identify and treat bones that have lost their

natural elasticity and vitality and preparing the skeletal system for further manual treatment."

Sternthal, who is credited as BST's developer, "breaks down complex concepts into clear, practical information in this hands-on guide for physiotherapists, manual therapists, osteopaths, chiropractors and bodywork professionals," according to the publisher.

In December, *Unwinding Bone* was the #1 new release on osteopathy in the US, according to Sternthal.

Back pain

In his practice, Sternthal sees clients suffering from lower back and neck pain, as well as other more general health issues like digestive problems.

While acknowledging that osteopaths don't fully understand the underlying causes of their clients' health problems, he said "we have techniques to address the symptoms."

Sternthal has been an osteopath for more than a dozen years. He said he chose osteopathy as a career after deciding he didn't want to spend too much time in hospitals. "I wanted to focus more on the wellness part of health," he said.

In my role as a roving reporter, part of the fun is discovery. Westmount is full of newness.

My most recent find was an armchair traveller moment: I went to South Korea. Jade Seo has opened Sum Gourmand on St. Catherine, but her creations are already well known in Montreal. For the past five years, Lufa Farms has carried her SUM Lab line of marinades and sauces.

"The lab is my kitchen," she said, where she cooks Sundays and Mondays, "as well as early mornings."

Jade brings fresh Bento box (i.e. re-useable) lunches, soups and sauces to her shop.

One super seller is *onigiri*. The traditional "sandwiches" are rice with savory fillings, with their triangular shape wrapped in *nori* (seaweed).

"As many high school kids come in, these are often sold out daily. And they're healthy," she adds.

Another of Jade's specialities is *kimchi*. International media has touted the benefits of this versatile ingredient's probiotic

qualities. Jade offers a choice: *kimchi* made with cabbage, radishes or *napa* (white cabbage). (She suggests beginners start with the *napa*'s milder taste.)

Jade's mother Oksun Koh is helping for a few months. "Her *kimchi* is really fabulous and I am learning from her."

In the spring, *kimchi* courses will be offered as well as making *onigiri*. "We're inviting children to take part as well."

Jade's home-cooked offerings include dumplings and pancakes that customers pick up and cook at home. Or choices can be heated in the shop as SUM offers take-away environmentally friendly utensils. SUM Gourmand seats 40 and has already been used for private parties.

Meals can end with a sweet note. *Yuzu* (Japanese for "lemon") cheesecake is a best seller, sitting mellow yellow beside my other fave: chocolate.

Lastly, Joohyeong Seo showed me the renowned line of Camellia teas. I'm sipping my green tea as we speak.

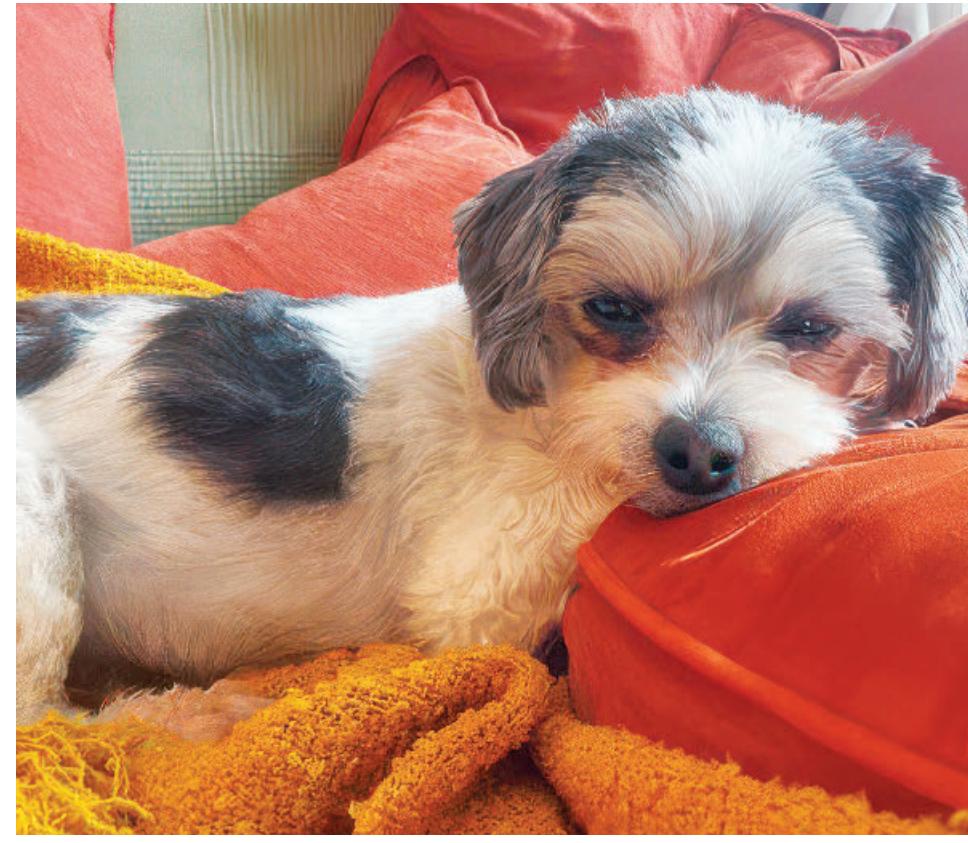

Raising money for breast cancer research

‘Carol for a Cure’ turns 15, adds \$10k to its \$100k-plus total

Again this December, a small group of amateur singers gathered on the steps of National Foods on Sherbrooke St. in Victoria village to raise funds for breast cancer research at the Cedars Cancer Foundation.

Having just completed its 15th appearance, Carol for a Cure was founded by Zoë Mintz in memory of her mother, Rochelle, who passed away from triple-negative breast cancer in 2016 after living with the disease for seven years. (Triple-negative breast cancer cells test negative for three receptors, which means that this form of the disease does not respond to common breast-cancer treatments.)

Since its inception, the event has raised more than \$100,000, including over \$10,000 this year, to support research aimed at improving detection and outcomes for patients.

This year’s event carries added weight.

A member of Mintz’s family – her cousin – was recently diagnosed with stage IV triple-negative breast cancer and was in attendance, highlighting the ongoing and urgent need for continued research.

“Breast cancer doesn’t stop when the holidays come, and it doesn’t stop with one generation,” said Mintz. “I lost my mom

to this disease, and now my cousin is living with it. Singing together is our way of turning grief into action – and of showing our kids that research isn’t abstract. It’s personal, and it’s lifesaving.”

All funds raised will be directed toward liquid biopsy research led by Dr. Catalin Mihalcioiu, Rochelle’s oncologist. – WI.

Police investigating possible art theft at Belvedere Circle home

Burglars use residents' ladders

Police at Station 12 filed reports for several attempted and successful household break-ins over the recent Christmas holidays, including two that were notable because the perpetrators used ladders that had been left in places where they were easily accessed.

Station 12 community relations officer Cst. Mike Yigit confirmed some facts about the incident reported by *The Gazette* late last week, including that valuable paintings stored at the home were removed following a break-in said to have taken place on December 30.

According to *The Gazette* account, the home's owner, a recluse, had passed away on December 24 after being assaulted around a month earlier.

Citing anonymous sources, including an expert in Canadian art, the report said the paintings included at least one by revered Canadian artist Emily Carr as well as works by Group of Seven artists Frederick Varley and Arthur Lismer.

"I know the case," Yigit said in a phone interview with the *Independent*. "But there's not much I can tell you right now because it's an ongoing investigation and I don't want to jeopardize anything."

"What I can confirm is that a gentleman passed away, that he had some art works, and there's an ongoing investigation to see that if some things went missing, whether it was with permission or not," he added.

As for the reported dates, he said "the dates are not clear so far. We're still figuring out the dates."

The Gazette initially identified the house as being in Westmount. It is in fact just east of the border, in the Ville Marie (down-

"Every year around this time, we get a few more break-ins in this area, and often times the criminals are using ladders belonging to the owners that have been left in a shed or an open garage," said Yigit.

"So, something for people to know is that even if they are at home, if they do have a ladder, perhaps it would be a good idea to lock it up and secure it so that no one else gets access to it."

Law enforcement officials as well as household insurance industry experts also advise home owners to not leave tools such as hammers, screwdrivers or crowbars lying openly around outside as they can easily be used by burglars to break in.

Be careful at gyms

Cst. Yigit is repeating a piece of advice he's offered in the past to people storing valuables in lockers while working out at the gym: you do so at your own risk. This comes after a recent upsurge of locker room break-ins at a local gym, including at least one in which a padlock was cut off.

Locker rooms are especially vulnerable, he noted, as there are usually no surveillance cameras because of privacy concerns. "So, when you go to the gym, keep it to a minimum, don't bring any expensive jewellery or watches," said Yigit.

Jeep stolen

While a wave of vehicle thefts that impacted Westmount last year appears to have largely receded, Station 12 received a report about a Jeep Wrangler stolen around 4 pm on January 13 from a parking spot near the corner of Grosvenor Ave. and Sherbrooke St.

Shoplifters active

Finally, shoplifters continue to be active at Westmount retail establishments. In a recent incident, staff at the Bureau en Gros office supplies store on St. Catherine St. discovered after viewing security camera footage that three suspects who walked in on January 15 walked out without paying with a boxed Epson printer.

Remembering Serge & Réal, Greene greats of fashion

A long time ago, in a galaxy far, far away, couture reigned on Greene. Serge Senécal and Réal Bastien opened Serge & Réal Couture there in 1987.

Their fashion creations had a cult-like following of Montreal's "swans" – Truman Capote's word for society ladies who lunched – wearing gloves, of course.

Designing for high-profile figures such as Governor General Jeanne Sauvé and Jacqueline Desmarais, their fame soon spread throughout Canada as well as New York.

Their designs mirrored the era. Hallmark pieces ranged from gorgeously glamorous ball gowns and chic cocktail suits to exquisitely tailored jackets and pant suits.

Listening to requests from their snowbird fans, they opened another salon in Palm Beach.

Trained in Paris, they created a signature style that entailed the impeccable construction of simple, elegant pieces. Retiring, they closed the Greene site in 2014.

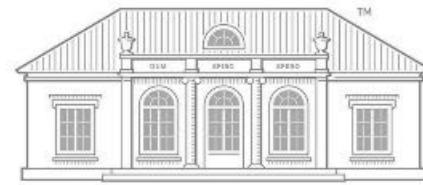
