

When is a bid too late? We'll know Apr. 20

City receives 9+1 bids for arena/pool project management

When is a tender submission too late? The question was raised over one of 10 bids received April 11 in the city's search for a project manager for the new arena/pool.

City clerk Mario Gerbeau stood at the downstairs door of city hall receiving the

bid packages and checking his watch with just minutes to spare before the noon deadline. Word subsequently came from Victoria Hall: a package had been delivered to him there at 11:55 am: Oops! Wrong location.

By the time he finally received it, it was 12:10 pm, he confirmed. The bid from Al-tapex was opened along with the other nine but held "in reserve" pending a legal opinion on its eligibility, he announced.

Even though this was obtained two days later, Gerbeau told the *Independent* at that time he had been asked not to disclose yet whether or not the bid was considered to have met the required delivery criteria and deadline for considera-

Last of city's three demerger labour agreements

Professionals' deal approved

City council approved in principle April 4 a 10.5-year collective agreement with the trade union representing the city's non-managerial professional employees.

The contract is the last one to be negotiated by Westmount after the forced mergers. Those with blue- and white-collar workers have already been signed.

The new agreement covers 14 employees whose positions require a bachelor's

degree. They include the professional librarians, accountants, engineers and an archivist. Before the merger, these were part of the white-collar agreement.

Spanning the period June 30, 2006 to December 31, 2016, the new agreement reflects the demerger reality, according to Human Resources director Alan Kulaga.

The big change from the previous Montreal contract lies in the pay difference between levels of progression that can take *continued on p. 9*

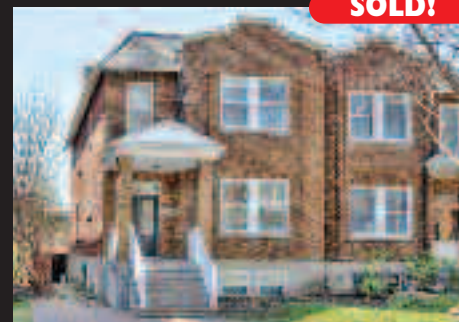

So, while the winner is expected to be announced at the April 20 council meeting, it remains unknown whether the evaluation is being made on nine or 10 bids.

All 10 submissions were opened publicly in the following order: Stavibel Services d'ingénierie, Planigram Construction Inc., Groupe Axor Inc., Genivar Inc., Decasult Inc., MHPM Project Managers Inc., Macogep Inc., Entreprise de construction TEQ Inc., Altapex Construction Corporation and Le Groupe Decarel Inc.

"Indeed it was a good turn-out of some very solid companies," said Councillor Patrick Martin, who chairs the arena/pool project.

Under the new Quebec system for the awarding of such professional services contracts, only an envelope containing the actual submission is opened initially.

After the content of each is rated by an evaluation committee, second envelopes from bidders containing their fees are then opened for those achieving a rating of at least 70 percent, Martin said. "I look forward to the results."

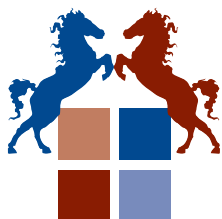

Panhandling creates circle of complaints

Banking clients complain to Royal, which complains to Public Security, whose tickets lead to resident's complaint

Jean-Guy Hébert, says he's being harassed.

Hébert, a homeless man who panhandles in front of the Royal Bank at Sherbrooke St. and Victoria Ave., says since the bank began calling Westmount Public Security two weeks ago, he has been given tickets totaling more than \$500.

"What they did today is harassment," says Hébert, of the four tickets – two for \$217 each he received April 14. The 62-year-old sits quietly on the sidewalk with a cup and sign asking for money. He said he doesn't understand why he is being targeted.

"Last year they said we tolerate you because you don't make trouble. If we get a complaint, you go away and then come back. It's just since the bank called a couple of weeks ago."

Sue Lapenna, a manager at RBC, confirmed the bank called public security about Hébert due to complaints from cus-

tomers.

"It's not the first time he's been here," she told the Independent, though she said she was not in a position to comment.

"We did call the city to complain. I did not know he would be fined. Our intention was to have him circulate away from the branch."

Hébert has befriended a number of people, including resident Joan McCordick, 57, who is a customer at the bank. She says she is upset Hébert is being singled out.

"I consider that he is being continuously harassed," she said.

"People should not be making complaints against him. My position is that he is not doing anything wrong and he should be left alone. He sits on the sidewalk extremely discreetly."

David Sedgwick, director of Public Security, says the situation is delicate, although he admits the city is cracking down on Hébert because of the number of com- continued on p. 23

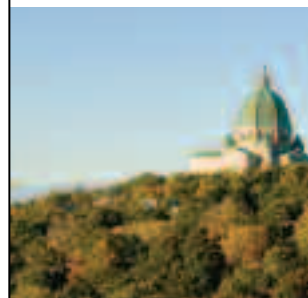

CITY NEEDS TO SHARE DATA ON WINTER BIKE PATH

Westmount Citizens for Safe Cycling (WCSC) asked city council last November to rescind its decision to keep the bike path open during the winter, basically for reasons of safety and security.

A two-way bike path on a one-way street, with no protection offered by bollards, contravenes all best practices, as indicated by the information tabled at that time. Councillor Gary Ikeman's answer was that cyclists would be using the path at their own risk. Other councillors stated that this was a trial and a report would be issued at the end of this experiment.

Now we find out, indirectly (see John Dorey's letter "Winter bike path too costly," April 12, p. 4), that some results are in and that a poll is being conducted to see where people stand on this issue.

How about sharing the results that council has in hand with all of us? How about explaining the evidence-based research methods used to obtain these results?

According to the letter written by Mr. Dorey, two assertions contained in the polling seem very shaky and incomplete:

1. According to the information Mr. Dorey received through the poll, it cost the city \$100,000 for snow removal to keep the bike path open. Are we to add to this the cost of \$75,000 in lost parking revenue,

which therefore brings the real cost to \$175,000 at a minimum?

2. According to the pollster, the daily useage of the bike path during winter was approximately 100 trips per day. From what data was this number derived? Certainly not on the observable data that we who live on de Maisonneuve observed during the winter months.

We appreciate and support the city's commitment to sustainability and to increased active transportation. However, actions and decisions in support of this commitment must be taken with a view to understanding the impact these decisions have on all citizens in Westmount.

Moreover, it must be grounded on evidence-based research and current best practices in the field – rather than what is politically opportune.

Greater transparency on the part of the city would be a plus. Our requests for access to the information that the city used to formulate the polling questions have gone unanswered to date.

He used to make a decent living but, through circumstances that could happen to any of us, he finds himself unemployed and homeless. Rather than openly asking for money, he displays a sign saying "Thanks for helping," and is unfailingly polite to anyone who drops money into his cup or stops for a chat.

He is clean, does not drink or consume drugs, and actively looks for odd jobs. In short, he is down on his luck and doing his best to get by. Yet his presence seems to offend some Westmounters, who complain to Public Safety; he is then ordered to move on.

He was recently served with a fine for "soliciting money without a licence." Having heard that some complaints had come from customers of the Royal Bank, I investigated, and was told that the bank had no choice but to respond to such demands. Ironically, Mr Hébert has several times alerted the police to card fraud at the ATMs of the four banks in that area, including the Royal Bank.

Thanks to his vigilance, the police were able to arrest the culprits red-handed.

I appeal to the readers of this paper to show some tolerance to this member of our community.

If you do not wish to interact with him, so be it; just walk on by, and please refrain from calling Public Safety to complain about someone who has not wronged you in any way.

BIKE BADGERING LEADS TO MISALLOCATION OF FUNDS

As an ardent recreational cyclist and a concerned citizen, I wish to comment on the bicycle paths and Bixi situations in Westmount.

Last year, the city agreed to forego parking meter revenues (about \$75,000) on the south side of de Maisonneuve during the winter months.

I would presume that this year, due to new parking fees, the loss of revenue should approximate \$150,000.

Another joyous announcement is the expenditure of \$235,000 for Bixi stations in Westmount. How many Westmounters are benefitting from this treasury largesse?

I have been involved in some council-ordained "ad hoc" committee meetings and feel that Westmount is paying because of the badgering of a very few.

At a past city council meeting, I questioned the presentation of the bike path being an "arterial bicycle thoroughway." Originally, the path was a street that was closed to enhance Westmount Park. "Why are we regressing to create a 'privileged' cycle thoroughway?" I asked.

We can have gates to slow down cyclists and keep the park safe for all, especially children. Those who need to pass through should be welcomed as long as they conform to rules and decency.

To summarize, in winter, cyclists can take alternate routes, walk or use public transportation.

Instead of Bixis, potential users can use their own bicycles.

Most citizens cannot derive any benefits from the expenditures. Instead, why not examine the use of this money to create a small bus shuttle system that would connect the flats to the summit? This would enable many to visit the lookout and the nature preserve, and provide a means for others to come down to attend civic functions and patronize our local businesses.

WINTER CYCLING POLL IS FLAWED

In last week's letters to the editor ("Winter bike path too costly," April 12, p. 4), Mr. Dorey concluded, after being polled, that keeping the bike path open in winter makes no economic sense. However, his calculation relied on the only two numbers provided by the pollster: the cost of keeping the path open and the number of cyclists using the path. Both numbers were misleading.

First, the cost to keep the path open included lost parking revenue and extra snow-clearing costs. No reference was made to the significant benefits of commuting by bike rather than motor vehicle, knowing the heavy toll of motor vehicles on our health, the environment and taxes to fund road infrastructure and health care to treat injuries and pollution-related diseases.

Westmount, like many other cities around the world, has concluded that the benefits of cycling far outweigh the cost and is therefore promoting active transportation in its sustainable development program and the Master Traffic and Active Transportation Management Plan.

As for the number of cyclists, that was based on counts this past winter when the city did not keep the bike path clear of snow, so many potential cyclists didn't use the path.

At the start of winter, the city stated it would not change its traditional snow-clearing program just to keep the path clear. Realizing the problem, our association repeatedly urged the city to clean the path to the same standard as the road. By

the end of the winter, the city admitted that it would have to make adjustments to keep the path open in future. Only after a multi-year test with proper snow clearing can an accurate long-term estimate of cyclists be determined.

We wonder how many other poll respondents came to the same conclusion as Mr. Dorey based on the misleading information provided.

Issues 224 by-law fines, 52,000 for parking

Public Security responds to more than 5,000 calls

Westmount’s Public Security Unit responded to more than 5,000 calls in 2010,

of which 3,000 were documented in detailed incident reports. Of all the calls – ranging from assistance at accidents to complaints of loud music – fully half occurred during the four months from June through September, according to annual figures released to the *Independent* last week.

The municipal force, which celebrated 30 years of service last year, issued more than 52,000 tickets for parking offences and another 224 for by-law violations (see story p. 9.)

“It certainly has been a busy time,” said Director David Sedgwick, who took the helm in January as part of the unit’s reorganization.

“I have the impression we used to have a quieter time patrolling,” he recalled. “We seem to be running so many calls now.” In fact, the unit’s four patrol vehicles clocked a combined total of more than 118,650 kilometres last year.

Sedgwick’s impression is underlined by statistics from 10 years ago (2000) when 1,994 incident reports were recorded compared with last year’s exact total of 2,955.

And that total from a decade ago would have included the unit’s routine response to most fire and ambulance calls before the creation of the island-wide force.

“Our goal this year is to get us as close to the public as possible,” he said. “We want to be more involved in more prevention and have a greater presence in the parks.” (See “Courtesy ticket”, p. 9).

Over the last few years, with the retirement of most of the original public safety officers, the unit has experienced a large turnover of personnel, Sedgwick explained. Now, however, the turnover has produced “a good mix” of younger and older personnel and “we want to get back that old community feeling,” he said.

While some comparative statistics from 2009 are not available, Sedgwick said, it is known that the number of parking tickets – and resulting revenue – dropped in 2010 to 52,012 from 63,623 the previous year. This was largely as a result of the refurbishment of Greene Ave.

Interestingly these compare with the equivalent of some 45,000 issued a decade ago and more than 54,000 in 1996.

Most tickets are paid on time, Sedgwick said. Those that aren’t go to Montreal Municipal Court as do those for by-law infractions.


All parking and by-law tickets that remain unpaid by the time they reach a court date rapidly accumulate additional costs. The court then follows various procedures for recovering the money. Failure to appear in court for traffic offences can lead to warrants for arrest.

“There’s always a chance that down the line if you’re stopped for a traffic check, you could be arrested if police discover there’s a warrant out for you,” Sedgwick explained.

While imprisonment for failure to pay no longer applies in by-law cases as it once did, in some cases the court can issue a writ of seizure or put a lien on a salary.

Other statistics last year include 513 requests to Public Security for Special Passing Attention. These are vacation checks that residents can ask for while out of town.



Park violations lead the list in 2010

Of the 224 tickets issued last year for by-law infractions, almost half related to city parks – a total of 104, Public Security officials revealed.

Most of these were for taking alcoholic beverages into the parks (62) or violating the midnight-to-5 am curfew (39). Three were issued for the riding of bicycles in parks.

Another 32 tickets were handed out for noise, mostly for leaf blowers and disturbing the peace.

There were 24 issued to dog owners for unleashed or unlicensed animals and an equal number given out for soliciting money without a permit. Still another 24 related to the nuisance by-law, most for drinking in public places (other than parks).

Received a new 'courtesy ticket'?

Public Security has recently started issuing "courtesy tickets" to motorists, cyclists or pedestrians when certain infractions are noticed.

"This is an option for us when we don't feel an infraction warrants a ticket," explained Director David Sedgwick. It's roughly the equivalent to the former warning tickets that are no longer used and could apply to a car parked too close to a driveway, for example.

"When the April 1 maintenance rules came in, we gave out more than 300 of the courtesy tickets," he said.

The ticket also has a section for "exemplary conduct." This may be used in an educational campaign, for example, to reinforce adherence to by-laws and good practices such as walking, rather than riding, a bike through a park.

at least 12 years to ascend from minimum to maximum levels based on performance, he explained.

The new agreement calls for increases of 3.5 percent between levels compared with 4.5 percent in Montreal.

"This is more adapted to the culture and philosophy of the city of Westmount," Kulaga said. But it was also the main reason that negotiations took so long.

The new contract also calls for salary increases that generally follow those in the white-collar agreement, up to and including 2013 when the latter expires. These rise from 2 percent to 2.75 percent (in 2012) and 2.50 percent in 2013.

The last three years of the professionals' contract will be based on those to be negotiated with the white-collar employees. This means the professionals' contract will not have to be renegotiated at that time, he said.

The agreement was unanimously accepted in principle at a general assembly attended by the 14 employees March 28, Kulaga said. The official name of the union is the Syndicat des professionnelles et professionnels municipaux de Montréal.

Q&A with Green Party candidate Andrew Carkner

Energy efficiency and fiscal conservatism – main focus

By LAUREN O'LOUGHLIN

Andrew Carkner, 29, is running for a seat in parliament representing the Green Party. This is the first time the engineer has run in a federal election.

WI: Where are you from originally?

Andrew Carkner: I am from eastern Ontario, the dairy farming country south of Ottawa. My grandparents were into farming.

WI: What is your family status?

Carkner: I am single with no kids – alas!

WI: What first got you interested in politics and why?

Carkner: When I was a teenager, I used to go to protests, but I started organizing them in 2006. Each riding has an associa-

tion. I co-founded the Westmount-Ville Marie Green riding in 2006.

WI: Do you read the *Westmount Independent*?

Carkner: I haven't. I don't actually live in Westmount. [Carkner lives in Verdun] Of course I have lots of positive things to say about it! I haven't seen anything in it I've objected to! [He says jokingly].

WI: Which aspects of the green campaign do you feel are most pertinent to the Westmount-Ville Marie riding?

Carkner: Mostly I have been focusing in the economic platform seeing as the commercial centre of Quebec is in my riding. There are two main points: we want more energy efficiency and also more fiscal conservatism, as there have been a lot of debts and spending. Both of those are not sustainable – that is how we put it – [we need to] live within our means.

WI: Where do you stand on the Green Party's plan to legalize and tax marijuana, and talking about its use among youth?

Carkner: The reason we want to decriminalize it is because the prohibition has been a complete failure for the exact

reason that alcohol prohibition was a failure. There is no point throwing good money after bad, but marijuana is still a recreational drug with harmful effects so in the interest of the health of Canadians we want to discourage its use.

WI: Do you think the Green party will ever have a majority government?

Carkner: I think we will. At this rate, environmental problems are becoming more and more serious. I know that it takes time to build a political party but there will come a time when our expertise and our point of view will become essential. That is my main objection with the other parties. It is not necessarily the things they do but just that their perspective is a 19th or 20th century perspective – and that is just not suitable for the kind of global problems we have.

WI: What do you do to live a greener life?

Carkner: I live within walking distance of work. It's about a half hour walk and that reduces carbon emissions from me.

Q&A with NDP candidate Joanne Corbeil

Sponsorship scandal cause to run in election

Joanne Corbeil, 51, NDP candidate for Westmount-Ville Marie, was born in Montreal, grew up in Laval and now lives in Kirkland with her two adult daughters. The former journalist is self-employed and works at the West Montreal Readaptation Centre, a rehabilitation facility for people with an intellectual disability, autism spectrum disorder or pervasive developmental disorder.

Last week, the *Independent* asked Corbeil about her foray into politics, and what she thinks she could bring to her constituency, if elected.

WI: What made you decide to enter into politics and run for the NDP?

Joanne Corbeil: I've been interested in politics since the sponsorship scandal, which made me realize that something was going wrong in Ottawa. Because I was just starting my business and had to focus on that, I couldn't focus on politics at the time. I befriended a colleague at work, who is an NDP member, and when the announcement of an election came up, she approached me and said, "I'm looking for

good candidates and I see you as a good candidate."

When she started to tell me about the NDP, I realized I needed to know more about all three parties. It made me learn more about the Liberals and the Conservatives to be able to compare. I would not accept being candidate without knowing what I was getting into. Totally to my surprise, when I looked at the NDP program, I could not believe how it matched the vision I had all my life.

WI: What difference do you think an NDP MP would make for Westmount-Ville Marie?

Corbeil: What I seem to get from residents at this point is they didn't feel their Liberal MP was as present as they would have liked. I don't know what their expectation of a presence is from an MP. They have to be aware that we have to be in Ottawa as well. [But] that would be something I would do, to be more present in the riding and supportive.

The NDP wants to reduce smog, which we are always stuck with every summer in Montreal. In terms of gas prices, one cent of the 10-cent gas tax would be pulled out

and invested in public transit. That would certainly help alleviate the smog. There are not enough buses, or financing of them. It's a federal/provincial agreement but if the funds are coming from the federal government to the province, it helps.

I attended a public assembly for the Empress Theatre. They just do not know how to go about getting public funding from any level of government. And they looked at me and asked, "Can you tell us what to do?"

That would be great – to be able to guide local residents through the maze of federal funding and try to match their needs with any programs available to them.

WI: In your opinion, what is the best possible election outcome for the country?

Corbeil: Ideally, it would be a majority NDP government.

Realistically, if there is a minority NDP government, it would be lucky because of all leaders, Jack is most willing to cooperate – and we're not talking coalition, we're talking collaboration.

WI: In your opinion, what is the worst possible election outcome for the country?

TBC Capital eyes developing nations for impact investing

Three investment professionals well-known in Westmount have joined forces to set up a new financial firm in the growing field of impact investing – a concept of mobilizing private capital for public good.

Former city councillor John Shingler along with Selwyn House graduates Geoffrey Moore and Geoffrey Adams embarked on the new venture in November after lengthy institutional careers.

All three told the *Independent* they had come to a point in their careers and community service where they wanted to use their backgrounds to generate investment returns through the funding of socially responsible projects, particularly in developing countries.

“Society and investors have options,” explained Moore, the CEO and driving force behind the founding of TBC Capital Inc. on Greene Ave.

Whether impact investors are helping finance multi-million dollar water projects or single mothers in rural villages who are trying to start up sewing or craft businesses, their money can generate a ripple effect in economic and social benefits while also delivering bottom-line returns, he said.

Focus on pension funds

Focusing on their collective interests and connections in Africa, the colleagues are compiling portfolios of opportunities to attract Canada’s large pension funds, high net worth individual investors as well as foundations that have matching interests in the fields of education, health care or ecology.

More traditionally, TBC will also serve as a link between Canadian pension funds looking to place money abroad and foreign money managers looking for Canadian clients.

All three associates believe the time has come for the new approach to helping

emerging nations.

“Historically the need for improvement in infrastructure, such as roads, water and drainage systems, was addressed through foreign aid,” Shingler explained. “And we all know what happened. The aid hasn’t always been well used.”

Another approach, he added, was the growth of African socialism in many post-colonial countries such as Senegal, Tanzania and Zambia where dictators took the place of democratically elected governments.

At 74, Shingler, the chairman of TBC Capital, has first-hand understanding of the historic perspective. In his native South Africa, at age 24, he led the National Union of Students that strongly opposed the government’s implementation of apartheid. In 1961, after opponents were targeted by police, Shingler left as a political exile but continued to work with South African groups in Canada. He lives on Burton.

Many students studied political science with him at McGill before he joined the financial services firm of Brockhouse Cooper 15 years ago and worked on its expansion into South Africa.

One student was Moore, who went on to intern at External Affairs in Ottawa. He then worked at Brockhouse Cooper, the Bank of Ireland and Deutsche Asset Management.

Now 45, he is raising his own family on Rosemount Ave. after growing up as the son of dedicated volunteers: the late Herbert Moore and former city councillor Barbara Moore.

“My parents led by example,” he said. “That inspired me to take a broader approach when I went to Togo with Canadian Crossroads International.” This is an NGO that sends students to work in developing countries.

A turning point for Adams, also 45 and TBC’s chief operating officer, has been his work over the last five years in establish-

ing fundraising for Sourires d’Afrique as its chef de mission. This is a mobile surgical mission in Montreal that brings cleft lip and palate surgery to west Africa.

Like Shingler and Moore, Adams also worked at Brockhouse Cooper before becoming an independent financial consultant. He was also an officer with Westmount’s Royal Montreal Regiment. Growing up on Roslyn, he is the son of dentist Dr. S.M. “Bud” Adams and Sylvia Adams (the nurse for the Town of Mount Royal). He now lives in Montreal West

where he coaches with the recreation department.

Together, the trio is looking to the future with TBC Capital, named for their aim of “Thinking Beyond Consensus,” to provide innovative traditional and alternative investment strategies “to everything we do,” Moore said.

“We’ve all had offices on the 40th floor of a skyscraper,” Shingler added. “Now we’re enjoying our more relaxed office on the second floor of a heritage building on Greene Ave.”

Senior’s purse stolen at Chine Toque restaurant

An 81-year-old Westmouter had her wallet stolen as she dined at a local restaurant.

The woman was at the Restaurant Chine Toque, 4050 St. Catherine St. at 8:30 pm on March 30, when two men entered and went up to the counter.

“The men ordered some take-out food and sat down at a table near the victim,” said Constable Adalbert Pimentel. “A few minutes later, they moved to the table right next to the victim, and left after paying for their food.”

The victim didn’t think much of the men moving closer to her until a few moments after they left, when she realized her wallet was missing.

“The red leather wallet contained \$150 and her credit cards,” said Pimentel.

The suspects are both described as white males, 25, 5’9” and 160 lbs, who wore white baseball caps.

Paid with credit card

The suspects paid their bill with a credit card that police believe may have been stolen from another Westmount resident.

“When you’re dining in a restaurant, never leave your purse on the ground or on the back of your chair with your wallet it in,” said Pimentel. “Keep your purse on your lap or in front of you, where you can

keep an eye on it. If you can, keep your wallet in your pocket.”

Two GPS units stolen on Greene

Thieves broke into a pair of cars and stole their GPS units in separate incidents on Greene Ave.

On April 5, a 38-year-old Brossard man parked his Nissan Murano in the lot at the corner of Greene and Selby. Sometime between 5:30 and 8:30 pm, someone smashed the driver-side window and stole the man’s GPS unit.

“On April 12, a witness saw a suspect shatter the driver-side window of a 2010 Kia Soul on Greene, near St. Catherine,” said Pimentel. “The car belonged to a 58-year-old Côte St. Luc resident, and his GPS unit was taken.”

Pimentel has the following advice for drivers.

“Never leave your GPS unit or its bracket in your car after you leave the vehicle,” he said. “Make sure no one is watching and place the unit and the bracket in your glove compartment.

“The same is true for other items, like cellular phones and laptop computers. Take them out of your car or place them in the glove compartment or in your trunk – again when you feel you aren’t being watched.”



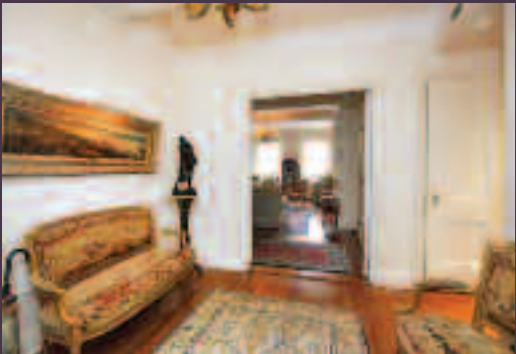

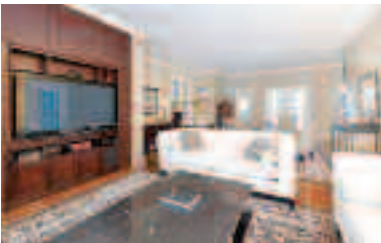

plaints they have recently received. He acknowledges other panhandlers in the last couple of weeks have been asked to move, while Hébert is being ticketed.

“For the most part he has been cooperative but now he has taken the stand to not move,” says Sedgwick.

“We are getting complaints specifically for him. That’s the root of the problem. The reason we are ticketing him is for loitering; he is refusing to leave.”

Sedgwick is referring to by-law 196 (sections 5 and 6), which covers loitering, begging and annoying or obstructing people in the street. See story to the right.

But Hébert says he’s not annoying anyone, and he does leave when asked to move, although he will return later in the day.

“They say go downtown, go downtown. The reason I don’t go downtown is there are a lot of homeless guys and most of them – 99 percent take drugs or drink – and I don’t. So I don’t want to be included in that bunch. I want to be alone.”

Sedgwick says there’s nothing much he can do when there are complaints, although he says the city is trying to get counsel from the police.

“There is a group within the police that deal with vagrants and problems, and we’re trying to get in touch with them for advice or recourse. We try to work with these people and help when we can, but we get complaints.”

Public Security says it has dropped one of the loitering tickets issued to Hébert because he had been sitting on a bench when it was issued.

As for McCordick, she would like to file a complaint of her own.

“Several customers complained they wanted him moving on. I find this so unfair and so outrageous. I spoke with an extremely nice woman [at the bank] who said there is nothing we can do. I am now com-

plaining in the other direction. I would like him left alone.

“I consider him to be a member of the community. He has a right to be there. He’s always the same – clean and polite.”

In the meantime, Hébert, who worked in real estate before falling upon hard times, receives \$242 a month from the Régie des rentes du Québec. His only other income is the \$20 to \$25 a day he collects in change from panhandling. He has no money to pay the fines. Hébert sleeps at Maison de Père and the Old Brewery Mission.

“Why are they always after me and why do they not bother the other guys? There’s no logic.”

What Westmount’s 1909 “begging” and “loitering” by-law says

By-law 196, which covers topics from indecent exposure, horse racing, shooting guns in the park, wearing immodest apparel and loitering, includes section 6, which targets “every person who wanders about and begs or goes about from door to door or goes into any street, highway, square, public or private place in the city of Westmount.” It continues that such people are subject to penalties if they beg or receive alms “without having a certificate signed within six months by a priest, clergyman, or minister of the gospel or two Justices of the Peace, residing in the City of Westmount, certifying that he or she is a deserving object of charity.”

Section 5 covers topics from loitering, screaming, swearing and singing in public places.

By-law 196 was passed at a special session of city council session on March 24, 1909 and has not been amended since, according to the city clerk’s office.

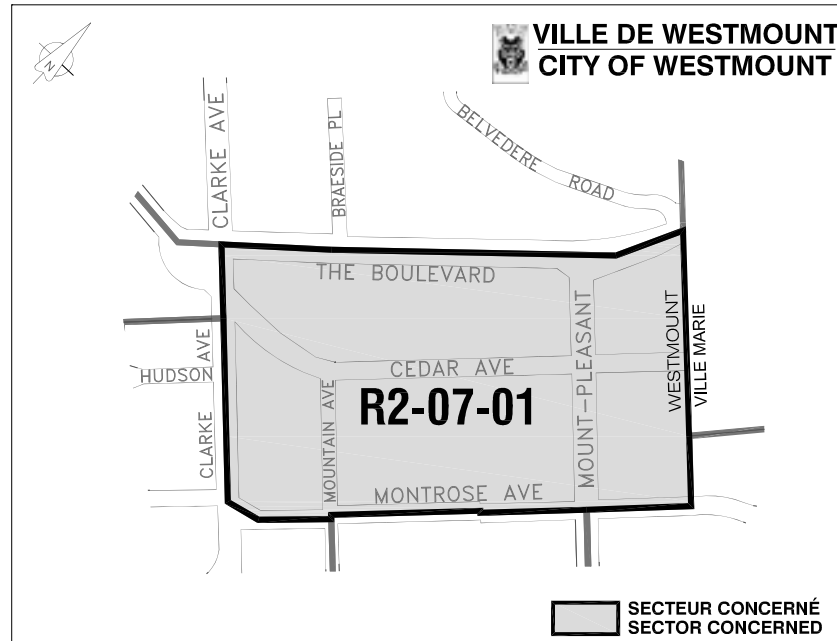

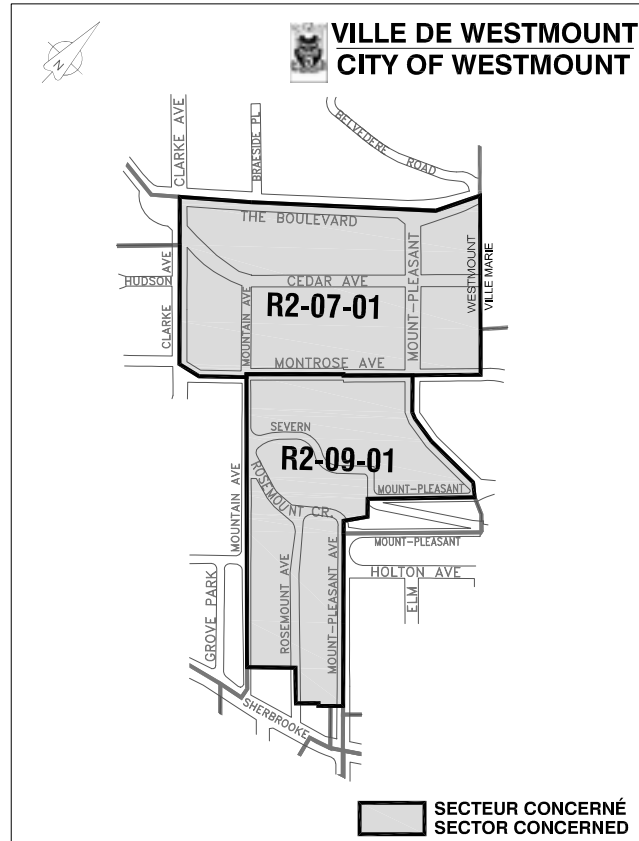

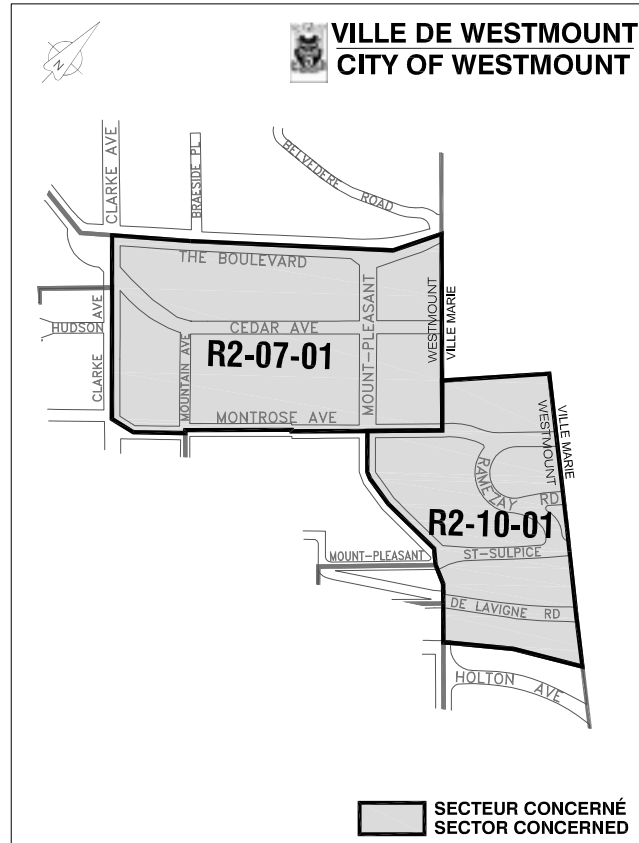

CONDITIONS TO BE A QUALIFIED VOTER ENTITLED TO HAVE ONE'S NAME ENTERED ON THE REFERENDUM LIST OF THE SECTOR CONCERNED

Is a qualified voter according to the following order of preference:

1. Any person not disqualified from voting and who meets the following requirements on **April 4, 2011**:

- is domiciled in the sector concerned;
- has been domiciled for at least six months in Quebec;

2. Any sole owner of an immovable or sole occupant of a business establishment not disqualified from voting and who meets the following requirements on **April 4, 2011**:

- has been, for at least 12 months, the owner of an immovable or the occupant of a business establishment situated in the sector concerned;
- has filed, or file when signing the register, a writing signed by the owner or the occupant requesting that his or her name be entered on the referendum list, as the case may be;

3. Any undivided co-owner of an immovable or co-occupant of a business establishment not disqualified from voting and who meets the following conditions on **April 4, 2011**:

- has been for at least 12 months, undivided co-owner of an immovable or co-occupant of a business establishment situated in the sector concerned;
- be designated, by means of a power of attorney signed by the majority of the persons who have been co-owners or co-occupants for at least 12 months, as being the one having the right to sign the register in their name and to have the right to be entered on the referendum list, as the case may be. The power of attorney must have been filed, or must be filed to be entitled to register.

In the case of a natural person, he or she must be of full age and a Canadian citizen, and must not be under curatorship.

In the case of a legal person, one must:

- have designated by resolution one of its members, directors or employees who, on **April 4, 2011**, is of full age, a Canadian citizen, not under curatorship, nor disqualified from voting;
- have filed, or file the resolution when signing the register, designating the person authorized to sign the register and to be entered on the referendum list, as the case may be.

Except in the case of a person designated to represent a legal person, a person shall have his or her name entered on the list in only one capacity, as per section 531 of *An Act respecting elections and referendums in municipalities*.

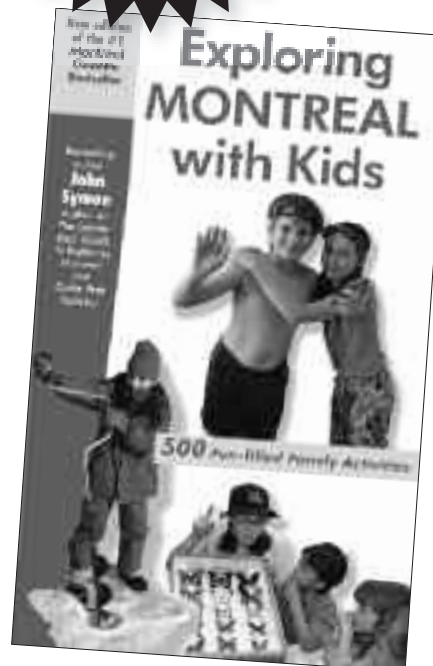

The McCord Museum is one of my favourite places to visit. I used to bring my daughter when she was young, and now I bring out-of-town visitors. Renowned as an institution showcasing all things historical, the McCord is celebrating its 90th anniversary with a special exhibit: 90 Treasures. 90 Stories. 90 Years. Suzanne Sauvage is the McCord's new president and CEO. I have always admired her style.

STYLE

How would you describe your personal style?

Being comfortable in my clothes is as important to me as looking good. So I would describe my personal style as casual chic, that, of course, is when I'm not gardening or running out to Atwater Market early Saturday morning hoping I won't meet anyone!

What is your favourite way of dressing?
