

Drainage problems deferred to residents in short term

Property owners have a responsibility to implement corrective measures to protect themselves against sewer back-up and flooding during heavy rainstorms in the short-term, Councillor Patrick Martin told the city council meeting August 6.

"It's very important that homes have backwater valves," he said. As well, eavestroughs on sloped roofs should drain onto the gardens rather than through the house drains.

Since sewer infrastructure was laid out to drain Westmount a century ago and can't be changed overnight, he explained, long-term solutions to the problem are currently being considered by the city.

"Studies are ongoing, and we expect to get to the continued on p. 5





New Public Security cameras in Stayner Park film purse thief in action

Newly installed surveillance cameras in Stayner Park captured on tape August 2 a man suspected of stealing a purse recovered soon after in the park comfort station by a public safety officer.

The handbag, along with a driver's licence and credit card, was returned to a woman living nearby before she knew it was missing from her car, according to Public Security director David Sedgwick. A bank card and cash were reported missing.

The suspect was described as a 61-yearold man of no fixed address, well-known to Public Security officials as one of a group of people hanging out at the park, to the complaints of nearby residents.

"It was one of the names we had given to police back a while," Sedgwick said.

The incident, as related, unfolded quickly after Public Security sergeant Steve Payne was checking out the comfort station just after 5 pm and discovered a beige purse along with some cards lying

on the floor of the men's washroom.

He returned the bag to the woman, who said it had been in her car – apparently parked and unlocked – on Prospect St. She was advised to cancel the bank card and complete a police report.

Suspect wheeled Bixi

When the camera tapes were played back, "a well-known vagrant," Sedgwick said, was observed at 4:25 pm approaching the comfort station with a black canvas shopping bag and a Bixi bicycle.

He was then shown removing the purse from the bag and cash from the purse, and leaving the washroom at 4:30. The suspect, he said, "is someone we deal with fairly often in the area."

What remained unknown, however, is how the individual came to be in possession of a Bixi.

The cameras at Stayner Park are "something we've been waiting for," Sedgwick explained. Those at Westmount Park, in particular, have proved to be a deterrent to

vandalism and have led officers to make interventions on many occasions, as previously reported. They are monitored by Public Security dispatchers along with other duties.

Residents' reports of anti-social behaviour at Stayner Park generated a city-led conference on homelessness and itinerancy May 30 (see June 19, p. 1).

Several reports of vagrancy and alcohol abuse in the Tupper/St. Catherine area were also reported by Public Security last week (see separate story).

'Polite' couple violates Stayner curfew

A couple seated on a bench in Stayner Park August 1 at 1:15 am was warned about the midnight parks curfew and asked to leave, Public Security officials said. They had apparently just left work and were described as "polite and co-operative" but their talking had disturbed a nearby resident.

Leaf blowers blow around the cash

The spring clean-up season for leaf blowers ended May 1, but public safety officers reported finding at least six in operation between July 31 and August 6. Their illegal use was either spotted by patrollers or generated complaints to Public Security. Tickets for \$267 were issued to contractors spotted at work on Forden, Edgehill, Upper Belmont and Sunnyside. A ticket for \$146 was issued to an individual – a lesser fine under the by-law – on Aberdeen.

Car left idling 'at least' an hour

A car reported to have been left idling for "at least" an hour was ticketed for the offence July 30, according to public safety officers. The \$50 fine for an engine idling more than three minutes morphs into a \$75 ticket when administrative fees are added. The car was parked in front of 4501 Sherbrooke at Mount Stephen when Public Security was notified just after 10:35 am.

Loitering in east end generates calls to Public Security Unit

Public Security officials said many complaints have been received concerning an ongoing problem of people loitering and drinking on the sidewalk and in lanes around Tupper St. and St. Catherine, especially outside a dépanneur just west of Atwater across from Alexis Nihon Plaza.

Among many incidents documented recently was one on July 31 when patrollers came across four people consuming beer in front of the dépanneur at 4018 St. Catherine St. at 10:10 pm. When two refused to leave the area between Atwater and Wood, police were called and ordered them to go, which they did.

A 37-year-old resident of LaSalle was eventually convinced to move along from in front of the store at 12:17 am on August 3, which proved to be a particular busy day.

At 10:40 am, a complaint was received for four people consuming alcohol on the grassy area across from the YMCA residence on Tupper just west of Atwater. Two fled when officers approached and collected the beer bottles. One of the two who stayed behind and was known to officers became "hostile" when an unopened bottle was taken away. He had to be restrained and was told he could pick it up at Public Security headquarters, where it has remained unclaimed. A bag of white powdery substance was reported destroyed.

That evening at 9:40 pm, an intoxicated woman sleeping on the pavement of the Tupper parking lot complained to officers of pain in the head and shoulder from a fight with another woman. She was staying at the YMCA residence and refused ambulance treatment.

Less than an hour later, another person described as well-known, was loitering opposite 41 Prospect and was "very co-operative" when asked to leave, and proceeded south on Greene.

Two days later, on August 5, a call was received at 1:28 pm for five aggressive individuals breaking bottles in front of 4010 St. Catherine. But on the arrival of public safety officers, no one could be found.

4 MUHC cooling towers permitted to rise here

Westmount city council approved August 6 a permit request by the MUHC superhospital to build four cooling towers at the southwest corner of the city territory. They would be immediately adjacent to a six-storey parking garage off St. Jacques St. on the Montreal side of the border.

The towers will cool water for the superhospital's air conditioning systems at the Glen campus, according to Councillor Cynthia Lulham, commissioner of Urban Planning and Parks, who singled out the permit request from among a list of nine others.

Only part in Westmount

They are the only part of the hospital structure to be located in Westmount, she explained. "They are very tall and not very

The towers will run parallel to St. Catherine St., requiring strategic positioning from the hospital. Panels for the control of noise and vibration are to be installed in such a way as to permit a flow of air around the towers.

"We won't notice them because they are against a background of the six-storey garage," Urban Planning director Joanne Poirier told the *Independent*. They will also be camouflaged behind a berm and ever-

The towers conform to Westmount's three-storey residential zoning of the land since they are "mechanical devices," she said. They will not generate steam.

Martin intervenes to save city \$80,000

Low bidder held to original price for Hydro cable

City council August 6 awarded a Hydro 18. They ranged from \$203,483 to Westmount tender for the supply of copper cable to a low bidder, stating the company could not withdraw its bid based on a claim it had made a calculation error.

The cable purchase had originally appeared on the July 3 agenda but had been removed after Councillor Patrick Martin, commissioner of Public Works and Utilities, objected to a staff recommendation that, given the attempted withdrawal, the second lowest bid be accepted even though it would have cost some \$80,000 more.

After seeking legal advice, Martin, who is also vice chair of the Montreal/agglo contracts review committee, insisted the city hold the supplier to the original bid.

"You can't just walk away from it," he explained, saying this was the first time he had seen such a situation where a low bidder, two days after the bids were opened publicly, tried to withdraw.

The tender bids had been opened June

\$303,773. The second lowest was \$286,109.

Withdrawal request rejected

At the latest meeting, the council voted to reject the withdrawal request and accepted the low bid of Lumen, division of Sonepar Canada Inc., for the supply of 1,060 meters of electrical cable, 15KV, XLPE, 1/0, twisted 3X1 copper conductor and the supply of 1,538 meters of electrical cable 15KV, XLPE, 500 MCM, twisted 3X1 copper conductor.

Interestingly, in a separate purchase item, the council also accepted a low bid from the same supplier for the purchase of additional electrical cable for inventory at a cost of \$76,263 in a tender opening that took place July 3.

In the latter case, Lumen was the lowest of four conforming bids. Another was listed as non-conforming.

Sports and Rec registration starts August 27

New skating venues unveiled, program booklet arriving at residences

Temporary venues for Westmount's hockey and scaled-back skating programs were unveiled at the city council meeting August 6 just as the new Sports and Recreation booklet was being mailed to all households.

With construction of the new recreation centre under way, arrangements have been made to secure ice time at the Point St. Charles arena, as well as Centre Gadbois under the Turcot interchange and the Concordia arena at Loyola – in addition to the city's newly acquired refrigerated out-

Registration for Westmount residents in all programs and courses takes place at Victoria Hall between Monday, August 27 and Wednesday, September 5, and thereafter for non-residents if spaces remain.

"Outside of all arena-based activities, all other programs for the coming fall and winter season remain unchanged," said Councillor Kathleen Duncan, Sports and Recreation commissioner.

Details and schedules for all programs and courses are listed in the new program

Two new programs are being introduced for kids: an introduction to music for ages 5 to 6 and yoga for ages 5 to 7. Another first-time course, for adults, is Knitting with Experts for the winter session.

While the hockey program remains generally intact except for scheduling and site changes, the skating program has been limited, except for beginners. This decision was made so that the following year when continued on p. 8

bottom of it in about a month or two," he

Discussing some of the factors involved in the widespread flooding during unusual back-to-back downpours May 29 and June 4, Martin said climate changes and conditions played a role. An unexplained change in rainfall conditions saw heavy rain that used to fall on the north side of the mountain fall to the south.

"I think it's important to outline the basics of a system laid out 100 years ago," he pointed out. Almost 80 percent of Westmount now drains through the Glen sewer to the St. Henri system, which has to collect all the water.

The drainage network has been well maintained in Westmount. This is one of the reasons the water flows so quickly

from the upper levels to the Glen. According to Martin, it has been calculated that water from part of The Boulevard takes only six minutes to reach the Glen.

Ever since the system was laid out, the city has been increasingly built up and paved over so that more and more rain water is forced into the sewer as less is absorbed into the ground.

"We're going to have to find a way to slow down the amount of water going into the sewer," Martin said. The city now requires all larger new buildings to include retention basins, which hold the water for a slower release into the system.

The installation of such basins, he said, may be one of the options the city pursues to slow down runoff in specific areas hardest hit by a sudden deluge. The city has been mapping out such locations. One is south of St. Catherine at Abbott and

Pierre Brunet of nearby Blenheim Place asked the council for information on ways of handling sewer back-up.

Information pamphlet available

Martin told him that an information pamphlet called Protect Yourself! prepared by the city of Montreal, was available at Westmount city hall. This illustrated publication explains the operation of home drainage systems and describes measures for preventing or reducing back-up as well as simple actions to take during heavy rain such as overloading drains through water

Councillor Cynthia Lulham, who has now had four backwater valves installed at her house on St. Catherine at Irvine, explained the importance of having a qualified plumber undertake the work and of obtaining a permit. Incorrectly installed devices can worsen the problem, she said.

Lulham, who has repeatedly called for drainage solutions, later said she was happy the city was recognizing that sewer capacity was a problem and was moving forward with studies. "If they're going to put in catchbasins, I hope they can be budgeted for installation next spring."

She added that the Urban Planning department and Planning Advisory Committee (PAC), on which she sits, were also looking at preventive ways of "building differently" as more land is filled in.

Next regular council session deferred to Sept. 10

The next regular meeting of city council will take place Monday, September 10, a week later than usual. Because Labour Day falls on the normal council meeting day of Monday, this year to be followed by the provincial election on Tuesday, September 4, the council agreed August 6 to postpone its meeting until the next Mon-

The first is animals shut in parked cars. It is not considered an offence and therefore no law or by-law is in place to protect these animals. Dogs are dying everywhere.

Gerdy of Gerdy's Rescues was involved in saving one of the dogs in your story "Officers warn 4 owners not to leave dogs in hot cars," (August 7, p. 1). She got the dog out of the car without breaking the window. But she was prepared to break it if necessary, whereby she could have been charged with breaking into a car. In fact, that is exactly what the car owner threatened to do to her, he was so livid. There was no thanks for saving his dog. He was concerned about his car seat, on which a bit of water had been spilled trying to get water to his dog.

Gerdy told him to go ahead and charge her. Witnesses had taken photos of his car, with the dog in it, and the licence plate, and were prepared to testify as to the time it took him to come back, not at all the "few minutes" he had claimed.

This is not new to Gerdy. Never has she been thanked nor had a contrite owner apologize. A beautiful dog is alive today thanks to a stranger and not his owner.



Campaign targets 'hot shot' cyclists

A bicycle campaign is being planned for the end of August targeting speeding cyclists on the bike path through Westmount Park, according to Dan Lambert of the Westmount Walking and Cycling Association (WWCA).

At the suggestion of Councillor Gary Ikeman, "we're planning to target aggressive cyclists," he told the August 6 meeting of city council.

While plans have yet to be finalized with the Public Security Unit and, possibly, police, Lambert told the Independent, he hopes the message gets through to cyclists to slow down through the park because of the number of children and others enjoying it for other activities.

"I want to be able to tell them if they want better infrastructure, they need to improve their reputation."

Police suspect connection in rash of vandalism

Throughout July and into August, six mostly high-end vehicles across Westmount have been the target of vandalism –

glass has been smashed, paint scratched and one bumper was splashed with acid.

Station 12 Commander Stéphane Plourde said it is a new, unusual trend, and police suspect the series of similar incidents may be related. Vandals are damaging the cars at all hours of the night and day with rudimentary tools, such as keys or sharp metal. So far, Plourde said there are no suspects and the investigation continues.

The list of incidents include: On July 5, a Saturn Vue's window was broken sometime between 5 am and 3:30 pm on Hallowell. There was no evidence of theft.

On July 10, a Porsche was burned on Belvedere around 10 pm. A Mercedes' rear bumper was damaged on July 11 by acid on Grosvenor sometime in the night. The acid caused less than \$5,000 in damage.

On July 26, a Mercedes on de Casson was scratched all over and a rear window broken.

A BMW on Sherbrooke near Olivier was scratched all over on August 1; a door handle was broken off, a panel dented and the windshield smashed. The incident happened sometime between 2 pm and 4 pm the next day.

On August 2, a Honda CRV was scratched on both driver-side doors around 3 pm on Claremont near Sherbrooke.

More Westmounters join Bixi, recorded use up 28%

Westmount's Bixi program, now in its second summer, has attracted 580 members this year, an increase of 16 percent over 2011, according to figures released last week by the city.

The five bicycle docking stations have also recorded a total increase of 28 percent in overall departures and arrivals for the period April to July over the same period the previous year, though the comparison appears not to reflect the fact that the program was only introduced to Westmount on May 9 last year (see May 10, p. 1), whereas the season began this year in mid-April.

This year alone, however, a total of 42,438 departures and arrivals were attributed to the Westmount docking stations, the most heavily used one being at Greene and de Maisonneuve.

Ikeman: program is popular

The increase indicates how popular the program is, said Councillor Gary Ikeman

in presenting the figures at the August 6 meeting of city council. "In summary, one could say it's growing and will continue to grow."

"I don't see how one can call it anything other than a success," Mayor Peter Trent told the *Independent*. "Mind you, that's still only some 3 percent of Westmount adults who are members."

He said he would like to find out from the city's traffic study consultants "whether they have any idea what this means in terms of fewer cars on our roads, or does a lot of this activity just take away from public transit use."

Over 6,00 arrivals and departures

So far this year, the Greene and de Maisonneuve docking station registered 6,610 departures and 6,518 arrivals. The others in descending order were: Victoria and de Maisonneuve, Victoria Hall, Hillside and St. Catherine, with the least used location being Argyle and Sherbrooke where 2,422 departures were recorded and 2,486 arrivals.

Gas leak evacuates Clarke Ave. residents

Three apartments break-ins, one suspect arrested

Three Westmount apartments were burglarized late last month and while a possible suspect in at least one of those incidents has since been arrested, his connection to the case has yet to be confirmed.

On July 26, sometime between noon and 4 pm, suspect(s) smashed in the front



doors of two apartments in the same building on Grosvenor. A laptop, jewelry and a set of keys were stolen, reported Station 12 commander Stéphane Plourde. He noted there were no surveillance cameras

On July 30, between 7 am and 5 pm, an apartment on Sherbrooke was burglarized. An iPad, jewelry and laptop were stolen. In this case, there were no signs of forced entry, explained Plourde, meaning the resident could have left the door unlocked. However, it is also possible that a lock pick was used to open the door, he added, as there have been a few cases of picked locks nearby in Montreal.

A well-known suspect was caught in possession of lock-picking tools in Montreal, and it was not the first time he had been arrested for burglarizing homes using such methods.

It is illegal, Plourde noted, for anybody other than licensed locksmiths to possess locksmithing tools. The suspect, so far, has not been charged with the Westmount incident, said Plourde, as there were no witnesses or cameras. The investigation is on-going.

Garneau not predicting where he'll run with riding changes

MP opposes name change

Citing the extensive break-up of the Westmount-Ville Marie riding as proposed by the Federal Electoral Boundaries Commission, the riding's MP, Liberal Marc Garneau says predicting where he will run in the next election would be "jumping the gun at this point."

The issue would have to be studied by his party before a decision is made, said Garneau, noting the next election isn't scheduled until 2015. The *Independent* asked Garneau if NDG-Lachine's election of Isabelle Morin, who represents the New Democratic Party, would deter him from running in the new riding.

Morin's voting base to be considered

He said the results of each polling station in the last election would need consideration before making that call, as the riding extends far into Lachine with a wide variety of voters from end to end.

When determining his chances of getting re-elected in the new riding, the studies would need to zero in on where Morin's voting base was in the last election compared to the thousands who voted for former Liberal MP Marlene Jennings.

In the meantime, Garneau is gearing up to oppose the proposed name of "Wilder Penfield" for the new riding. The new riding includes Westmount, NDG and Montreal West. About 45 percent of Garneau's current voter base would be shifted into Penfield.

"Every 10 years, when they change the names for ridings, they're supposed to keep the names that represent the geographical communities," said Garneau. "It would be more sensible, in our opinion, to call it Westmount-NDG-Montreal West so then people in those three communities see their names and identify with that."

Garneau remembered campaigning door to door in NDG westward to Hingston Ave. and several residents, he said, were surprised to learn they were in the Westmount-Ville Marie riding. It's important, he said, that the individuality of each community not be broken up into different ridings.

August 27 deadline for comments

Officials and citizens opposed to the new name or boundary lines have until August 27 to submit those concerns to the commission, and Garneau said he will be submitting a formal complaint about the name. The MP is encouraging residents to contact his office with their views so he can learn more about how the public is feeling over the proposal.

A public hearing takes place on Friday, October 19 at the Montreal court house.

Still considering party leadership

While that continues, Garneau said he is still considering his bid for the Liberal Party leadership. It is something he is interested in, he said, but first needs to find out if he has the needed support to launch a campaign. That vote will be held in the spring.

Regardless of what the future may hold, Garneau said he wants to make "one thing absolutely clear. Until the next election, I represent Westmount-Ville Marie with its current boundaries. Those are the people that voted for me in the last election and those are the people that I represent."

Morin was on vacation and unavailable for comment on the riding name change proposal by press time.

of the country's "iconic neighbourhoods," comprising a national historic site.

The resolution is being sent to the Federal Electoral Boundaries Commission, as well as Prime Minister Stephen Harper and others.

"I intend to write a covering letter to the prime minister reminding him of all Westmount has done for Canada over the years," including being the home of two former prime ministers (Brian Mulroney and Paul Martin), Trent later told the *Independent*.

Trent said he would also point out that directives to the boundaries commission noted that municipalities were to "form identifiable building blocks" in creating ridings. "Surely the nomenclature of districts should equally follow such principles."

Community of interest

The proposed name change, the resolution states, ignores Westmount as "a

community of interest" and "integral to the riding's identity" despite these being two criteria the commission was being asked consider in the redistribution.


Outremont keeps name

It also points out that names of other communities on the island of Montreal, such as Ville Marie and Outremont, had been respected while Doctor Penfield Ave. "is not even to be found in the new district." In fact, Trent noted, Outremont was designated as its own riding.

During the question period that followed, Maureen Kiely, a resident of The Boulevard, called the name-change "crazy." How were people on election night "ever going to figure this out?" she asked. Saying the riding changes seemed to have been made haphazardly, she hoped Westmount's resolution would influence other ridings across Canada to object to their name changes.

Public consultations on the riding redistributions are planned for the fall.

The PQ's Marc-André Bahl, Québec solidaire's Mélissa Desjardins and Option nationale's Benoit Guérin have yet to reply their invitations.

He was, however, able to talk about his record and how it affects Westmounters. 

As far as I'm concerned, the Green Party of Québec (we are bilingual!) is a federalist party wanting to keep all of Canada green (therefore against separation). We like to think we are a 'globalist' party; for a healthy planet with responsible and a durable/sustainable economy."

At least three choices for separatists

The péquistes' headquarters was contacted via their principal website on August 9 (no answer was received) and, like many respondents, by individual email and phone call on August 10 (which did elicit replies), but they did not submit answers in time for publication. Their candidate is Marc-André Bahl. His biography is not yet posted on their campaign site.

Québec solidaire's Mélissa Desjardins, 27, is a vegan caterer and lives on the Plateau. According to her, "Quebecers should vote for Québec solidaire because it is a party that will stand for Quebec's citizens... Quebecers want real social

projects. [For example,] Québec solidaire will enable Quebec to regain control over its resources by nationalizing the strategic

resources for which Quebec has extraction and exploitation expertise ... Also, it is vital to set up an adequate system of royalties for extraction and industrial use of natural resources, including water, to ensure that the benefits are fairly distributed between regions and the state."

Westmounters in particular should vote QS, because it has "an extensive green plan that would add to their quality of life. Québec solidaire will prioritize public transportation ... as well as repairing roads and bridges. Québec solidaire will restore Transport Quebec's expertise and vocation, which is to serve the population, notably by limiting the use of subcontractors. Québec solidaire will increase public transportation in major cities and will also electrify the entire network, plus ensure affordable access to public transportation everywhere, and to aim for free transportation within ten years."

Interestingly, in a time when pension plans are being cut back, "Québec solidaire proposes a guaranteed minimum income and will implement, with the goal of totally eliminating poverty, a guaranteed and unconditional minimum income, which will initially be fixed at \$12,000 ... This income will be paid on an individual basis, starting at age 18, to replace welfare or to supplement either a work income or another income support. ... Québec solidaire will progressively transform the Quebec Pension Plan into a universal public pension plan. It will cover self-employment and the invisible/unrecognized continued on p. 18

House history

The lovely stone mansion at 736 Lexington Ave. was not built until 1930, but the notion of developing the Summit area dates back to 1909 and probably even earlier

William Murray, whose mansion (now demolished) off Côte St. Antoine actually inspired Westmount's name, was a wealthy 19th-century investor, who founded Beaver Shipping Lines but also purchased in 1849 the Leduc farm, which stretched up the mountain in central Westmount above Côte St. Antoine. Murray died in 1874, but his family held on to the property for many years, and in fact it appears that the strip of former farmland – along with the strip to the east, owned by the Raynes family – formed the Westmount golf course.

The demise of the golf course came in 1909, as the Murray estate sold the portion of land north of The Boulevard for 15

cents per square foot, representing a total \$195,837.90 to Herbert Holt, president of the Montreal Light, Heat and Power Company, and Charles Gordon, president of Dominion Textile Company. The amount included a balance of sale of \$145,837.90 at 4.5-percent interest, and stipulations for repaying the loan indicated clearly that division of the lot and sale for residential development was anticipated.

Soon afterward, the concept of "West Crescent Heights" was being advertised as "The most beautifully laid out location for a private residence in Canada, bar none... You have the whole city and suburbs, including the lake, before your eyes. There is absolutely nothing to beat it" (*Westmount News*, January 1912). The advertisement suggested a price of \$1.25 per square foot for vacant land, but with the start of World War I in 1914, by the time the lots were redivided and sold off, Lots 237-58 and 237-59 sold for only 50 cents per square foot, representing 10,849 square feet.



736 Lexington history

emplacements situated in the City of Westmount in the District of Montreal, on 'West Crescent Heights'..." On the basis of the advertising and other information, it appears the "Heights" stretched all the way across the front of the mountain, since the Noah Timmins mansion, on the opposite side of Westmount mountain on what is now Belvedere Place, was considered part of West Crescent Heights (Canadian Architecture Collection, McGill University).

The lots sold to McNally on June 23, 1915 were to be used "for the erection of a private dwelling or dwellings and accessories only, and any building which may be erected on said lots shall be a first-class dwelling, detached or semi-detached, and accessories, built of stone, or solid brick on stone or concrete foundation only, and of the value of not less than seven thousand dollars, and not more than one dwelling house shall be erected on a single lot, and no saloon, restaurant, shop or livery stable, and no slaughter house, tannery, factory, hospital, medical school, soap or oil factory, or buildings for the purposes of carrying on any trade or manufacture which may be deemed a nuisance by the vendors to be erected, established or carried on on any part of the said land; and to allow poles for the conveyance of electric and telephone wires and cables to be placed on the rear of said property."

Whether the building requirements were stipulated by the city at this stage or the vendors who were planning West Crescent Heights is unclear. McNally died in 1924 and the lots still were vacant when his sister-in-law, Dame Catherine Louise-Ellen Daley of West Springfield, Mass., sold the two lots to two different owners. John Fellowes, a builder, purchased Lot 237-58 in June 1926, and began designing the house which became 736 Lexington Ave. In the meantime Sunnyside Ave. was

built with a slight twist away from the lot next door, which was sold to Hugh Brodie, a sales agent, who added extra land to the original lot and held on to it until 1952, when he sold to Nathan Gelber, who built a much larger house at the corner of Lexington and Sunnyside.

National Trust, a Toronto-based bank, held on to 736 Lexington for decades and apparently William Eakin continued to rent it until 1967, when his daughter, Shirley, purchased the house for \$70,000 and moved in with her husband, Ian Black.

The Blacks only stayed there for five years before selling to Hugh Lawson, an investment dealer, who owned the house for a year and sold to Ulrich Van der Walde for just under \$100,000 in December 1973. Van der Walde sold in June 1978, to J. R. André Bombardier, the youngest son of J. Armand Bombardier and the vice-president of the industrial division of Bombardier, Inc., who paid \$175,000 for the house.

In 1980, Bombardier transferred the house for a brief period to Restaurant A&W (Hamel) Inc., of which he was president, but he took it back after two months. A divorce judgement in 1981 allowed his wife and children to remain in the house while he retained ownership for a little over a year until he sold it in April 1982, for \$415,000 to Robert Hill and Margaret Kerr. Five years later, Arthur Katz purchased the house for a declared value of \$750,000; he owned it for 12 years before selling for \$1,075,000 in 1999.

The final sale, to Angela Costa, wife of Giuseppe Rizzolo, took place in February 2009 for \$1,475,000. The municipal evaluation, which had been \$2,107,800 in the 2007 valuation roll, was reduced to \$1,824,000 in the latest roll, which is supposed to represent market value for July, 1, 2009.

will be timed for the start of the new school year when traffic on the bike path is expected to pick up.

The subject of cyclists riding roughshod on sidewalks was also raised at the council meeting by Shelley Kerman, owner of LMNOP, who called the situation "ongoing." She said she couldn't understand why the problem has not been addressed by police and Public Security. "I

know it's a moving violation, but nobody is out there."

"We'll have to give them tickets," said local police commander Stéphane Plourde from the audience. He pointed out that police have a bike patrol.

Mayor Peter Trent said the city would be looking at the possibility of Public Security giving out tickets, adding: "without upsetting police."

Public Security officials have long stated that the ticketing of cyclists on public sidewalks is very difficult for them without being able to pursue a fleeing cyclist. Officers are starting to ticket cyclists riding on park pathways this week.




